HERBERT PHILIPO ALLOTMENTS – PLOTS STILL AVAILABLE FOR RENT!

The Parish Council still has some allotments available to rent, opposite the School in New Road.

These allotments were intended to help bring an income into the village and therefore the Parish Council do not wish to leave them unallocated.

The allotments are ready for use with water available from a central tap. Sheds are permitted on individual plots with prior permission. The allotment area is fenced to prevent rabbits stealing the produce! Rent is currently £30.00 per annum and due in September. Manure is occasionally provided for tenants use at no additional cost. A gate has recently been installed across the access road to prevent unauthorised parking by non-allotment holders.

Community Speed Watch

The police are keen to support existing Community Speed Watch schemes as well create new ones. Put simply, speed monitoring is carried out by trained volunteers from the community, with follow-up work on education and enforcement by Norfolk Safety Camera Partnership, Norfolk Police and your Local Authority.

Initially, letters are sent to registered keepers of offending vehicles asking for their assistance in keeping speeds down in your community, with persistent offenders targeted for police enforcement. Local Authority Road Safety staff can help with supporting initiatives, including the use of Speed Awareness Messaging Devices (SAM's).

There should be a minimum of six volunteers in the scheme, each willing to contribute a minimum of one hour per week. Small communities who are unable to reach this figure are encouraged to link with other interested local councils/groups, with a view to joining together for a wider-area scheme and sharing the equipment. Volunteers must be over 18 years of age and will be subject to a vetting procedure. Volunteers who do not wish to be involved in speed monitoring may assist with administrative support, and each scheme must include at least one person in this category. Some volunteers may, of course, can do both.

The Parish or local Council must support the scheme. The locations for monitoring are chosen by the community, based on their experience and knowledge of the area. Supporting data may be available from the police or local authority. Risk assessments will be carried out by a trained officer, who will approve the nearest safe site to that chosen. All sites must be within 30 mph or 40 mph limits. Training for volunteers will include use of the equipment, and health and safety issues both general and site-specific. This training may be cascaded to new volunteers by scheme members but direct approval must be given by Norfolk Safety Camera Partnership following vetting.

1. APOLOGIES

Apologies were received from Cllrs P Carrick and G Crane.

2. DECLARATIONS OF INTEREST AND DISPENSATION REQUESTS

There were no declarations of interest or dispensation requests.

3. MINUTES OF THE LAST MEETING

Minutes of the meeting held on the 6th September 2016 were agreed by all and signed by the Chairman.

4. MATTERS ARISING

An email has now been received from Saffron who are arranging for an external contractor to aerate the turfed area and instate ditches / channels as required.

5. MATTERS FOR DISCUSSION AND ACTION

a. Herbert Phillipso Fund

Following discussions it was agreed that the cost of implementing the lease proposed by Circle Wherry far exceeds the £6000.00 the Council agreed to put towards the project and is therefore not acceptable. Cllr A Ramsbottom will refer back to Circle Wherry. County Cllr D Roper agreed to speak to District Cllr P Carrick and BDC to see if BDC can do anything to assist with the play area situation.

b. Finance

Barclays account

The Clerk has been notified that the interest rate will decrease from 0.05% to 0% with effect from 5th December 2016. The Clerk is still looking to see if there are more suitable accounts available.

Income and Expenditure for the 6 months to 30th September 2016

Figures were circulated and agreed.

External Auditors Report

The auditor's report had now been received and apart from a slight amendment to allow for unpresented cheques, all is in order. The necessary notices have already been placed on the notice boards and website.

d. Local Government Settlement Consultation

The Clerk advised there are really only 4 questions relevant to Parish Councils within this consultation. Following discussions it was agreed the response should be 'no' to all 4.

e. Heritage Rangers

Information regarding this had been previously circulated and all agreed the Church was the only historic building within the village which may benefit. The Clerk will inform BDC of this and confirm the Council are happy to help advertise the scheme should it go ahead. The Clerk will also pass the information onto the new vicar.

6. MATTERS TO REPORT

a. County Councillors Report

Highways are chasing the signs for Low Lane. The query Cllr P Carrick raised in September, was not a new project but an update of an old system already in place. The devolution decision has been delayed and is now expected by the end of November. The budget consultation begins on the 31st October and will run until early January 2017. An overspend of £22 million is predicted for this year. Cllr D Roper will press Highways again on the Clerks outstanding issues.

b. Clerks report

The Clerk has received an in depth letter from a parishioner concerning the amount of dog fouling in the village. The Parish Council are limited on what action they can take regarding this so the Clerk has reported the main problem area (Low Lane) to BDC for them to cleanse and monitor. The Clerk has also put a notice on the website and notice boards reminding dog owners of their responsibilities, providing details of BDC's Top Dog campaign, and detailing how to report dog fouling to BDC. It was too late to publish the letter in the magazine but should the problem persist the Clerk will ensure the letter and an article goes in the next magazine. The Village Hall was another area mentioned but with such a large open area it is difficult for the cameras to pick up the perpetrators. There is a dog bin within the hall grounds so there is really no excuse for leaving anything on the ground.

d. Village Hall Report

The committee have agreed that once the new fencing is in around the play area they will not need the grass cut right up to the fence but will weed kill this area to prevent damage to the new fence. The Clerk asked if they were happy with the standard of the grass cutting of late and Cllr J Norton advised they were not. Cllr T Palmer also commented that on some occasions the Village Green has been left looking a mess. The Clerk has also received complaints from the Church this year so will look to place the contract elsewhere next season.

2 quotes have now been received to remove the old fencing and erect the new supplied by Caloo. The Clerk opened both and all agreed the work should be offered to Mr R Bowes and Mr D Seppings.

The committee are still having problems with misuse of the bins at the hall and so they are now going to be moved and a cage installed around them. All hirers will be given a key to access.

7. PUBLIC PARTICIPATION

Cllr D Fox-Willis stated residents of Nelson Way and Churchill Close are having problems with a large white van parking inconsiderately. BDC have advised it is a Police matter and the Police have said as nothing illegal is actually being done they cannot take any action. It is believed the owner lives in a Wherry Housing property and therefore it was suggested that residents get together and contact Wherry to see if they can intervene.

Cllr A Ramsbottom asked if anything can be done about the 6 overgrown oak trees which run alongside properties on Pound Close. It is believed they have TPO's on them and they used to be maintained by BDC but are now pushing into the fencing of some of the properties. The Clerk will see what she can find out.

The Laurel Club have received BDC's gold award for the lunch club (including the hall kitchen) and meals on wheels service. The Laurel Club would now like to trial a new project over the winter months to support the elderly and more vulnerable in the village in 'emergencies' and provide information to prevent difficulties. Meals on wheels volunteers will be used but they would like to be able to offer a mileage allowance. Cllr A Coldham asked if the Council would be prepared to consider a start up grant of £200.00 to allow for advertising. A Facebook page is also being set up to advertise to the younger generation in the hope they will pass details onto those who may benefit from the service. All agreed to grant £200.00 on the condition that if it is not all required any surplus is returned to the Council.

The Chairman advised the hedge which runs alongside the footpath down to Westgate needs cutting.

Expenditure relating to the Herbert Phillipo Fund is listed.

There is lots of information from the Police, the Safer Neighbourhood Action Panel and Operation Randall including crime figures each month for the village – check out what crime is happening near you!!

Consumer alerts are updated regularly to help prevent you being scammed and highlight product issues.

All planning applications are shown with the Councils basic response to either Broadland District Council or Norfolk County Council.

There are lots of useful contact telephone numbers along with news and information relevant to the village. If a number is missing and you would like it added, contact the Clerk.

The 'Hevingham News' is now on there too, so if for any reason, you don't get your copy, you don't have to miss out!

REPORTING HIGHWAY ISSUES IN THE VILLAGE

Did you know you can report problems with footpaths (including public rights of way) and roads direct to Norfolk County Council? In days gone by these matters were always reported to the Parish Council, who then reported them to NCC, but as with all things nowadays things have moved on!

So, if you see a blocked, damaged or overgrown right of way, an overgrown verge, a pothole or two, or a damaged sign etc. you no longer have to wait until the next Parish Council meeting to report it – you can go directly to: <https://apps.norfolk.gov.uk/highwaysdefect> and report it immediately. You can choose to register so you can track the progress of your issue or simply report anonymously – the second option will not allow you to track progress. Reporting yourself will guarantee accurate information is provided to Norfolk County Council.

HOPE TO SEE SOME NEW FACES

Wow, wow and wow again!

What an amazing response to our Gift Day and collection at the Carol Service to raise money to replace the lead stolen from the roof. A total of £1,227! Gift aid will add another £300 so over £1,500 raised. Thank you all so much for your donations; there's a real generous spirit in the village. The congregation and I really appreciate this; it's a wonderful sign of your love for this special historical church. We are currently asking 3 contractors to quote for the roof repair so we'll know *exactly* how much more we need to raise. We know approximately the total cost, including the fitting of an alarm system, will be £30,500. The alarm system is fitted. We received a £1,000 grant towards the £5,500 cost of having this. We're also applying for another grant which may contribute more towards this part of the project. The insurance paid out £9,344, we raised £477 at the harvest supper and with other donations we've raised a total of £13,350. So just over £16,500 to go! You can be certain all money raised for the church roof will go towards its repair. A project team is being formed to apply for grants, arrange fund raising and manage the project. There's much to do but we aim to have the work started, if not finished, this year.

HEVINGHAM VILLAGE HALL

Hope you all had a wonderful Christmas and New Year... The Hall was busy over the Christmas period and continues to be running smoothly. Our transformation outside is almost finished, as promised the new Spacecraft arrived and has proved so popular with the children, sooner than anticipated the extra fencing has been ordered and erected with thanks to the Parish Council, Rick, David and Jacqui for their precious input. Also, the new Picnic bench has been placed in the play area and a Sea Saw is scheduled to arrive in the coming months. Then the community will have a lovely secure play area for all children to enjoy and a great asset to Hevingham. The Table Tennis Table from the Youth Group is to be erected near the teen shelter and basketball area. You will have noticed that we were forced to take measures and secure our bins, the locked area erected to the side of the shed is now all in motion. Inside the hall, we are at present having automatic sensor lights fitted to the toilets and new ceiling fans, and a new light fitted to the loft space, cost £750+VAT. Rope light for the main hall is still in progress. We have also just had all the curtain tracks replaced in the main hall as the old ones were going rusty and curtain fixings broken, repairs to blinds in the best room were done too, total cost £439. So, with these added to money spent on new Play Equipment and just having to pay for Annual Insurance and other maintenance jobs our bank balance has taken quite a big hit. The Hall has been booked for Polling Station on 4th May. Once again, I must stress and remind you of our need for any one prepared to take on the roles of Chairman, Secretary and Booking Clerk to take over at our Annual General Meeting this year in MAY/JUNE. Please contact myself or a Committee member if interested.
