HERBERT PHILIP ALLOTMENTS – PLOTS STILL AVAILABLE FOR RENT!

The Parish Council still has some allotments available to rent, opposite the School in New Road.

These allotments were intended to help bring an income into the village and therefore the Parish Council do not wish to leave them unallocated. The allotments are ready for use with water available from a central tap. Sheds are permitted on individual plots with prior permission. The allotment area is fenced to prevent rabbits stealing the produce! Rent is currently £30.00 per annum and due in September. Manure is occasionally provided for tenants use at no additional cost. Weed killing has regularly carried out to the central access road and all un-used plots. A gate has been installed across the access road to prevent unauthorised parking by non-allotment holders.

BRICK KILN ROAD (18th Feb 18 – 20th March 18) – 20MPH LIMIT (2)

13,714 vehicles drove past.

11,657 within the 85th Percentile Limit of 27.6mph.

2,057 over the 85th Percentile Limit.

Average speed of those over the 85th Percentile Limit was 25mph.

Overall average speed 20.7mph.

Max speed recorded was 60mph at 15.45 on Friday the 23rd February 2018.

BRICK KILN ROAD SITE 2 (24th March 18 – 24th April 18) – 30MPH LIMIT (1)

12,855 vehicles drove past.

10,927 within the 85th Percentile Limit of 36.5mph.

1,928 over the 85th Percentile Limit.

Average speed of those over the 85th Percentile Limit was 35.5mph.

Overall average speed 28.5mph.

Max speed recorded was 60mph at 21:50 on Thursday 5th April 2018.

THE HEATH (2nd May – 31st May 18) – 30MPH LIMIT (3)

6,315 vehicles drove past.

5,368 within the 85th Percentile Limit of 36mph.

947 over the 85th Percentile Limit.

Average speed of those over the 85th Percentile Limit was 36mph.

Overall average speed 28.2mph.

Max speed recorded was 75mph at 11:20pm on Sunday 6th May 2018.

The **85th Percentile Speed** is the speed that 85 percent of vehicles do not exceed. Another way of looking at this is that only 15 percent of vehicles go faster than this speed, and 85 percent go at or below this speed. The 85th percentile speed may vary slightly each time as this is based on the first 85 vehicles in 100 and is dependent on the speed that the vehicles are going through the sign. This is better than taking an overall average and it excludes the odd high speeders which would give false figures. Drivers who exceed the 90th percentile have a significantly higher risk of crashing. The Police use the 85th percentile speed to set speed limits and check they are appropriate.

PRECIS MINUTES OF THE MEETING OF HEVINGHAM PARISH COUNCIL
HELD ON 6th MARCH 2018 AT THE VILLAGE HALL

1. APOLOGIES

No apologies to note.

2. DECLARATIONS OF INTEREST AND DISPENSATION REQUESTS

The Chairman declared an interest under item 6h as a landowner.

3. MINUTES OF THE LAST MEETING

Minutes of the meeting held on the 9th January 2018 were agreed by all and signed by the Chairman.

4. MATTERS ARISING

It was reported that a reduction in the speed limit on the A140 Cromer Road has been approved although the exact stretch it will cover is yet to be agreed. It is anticipated this will be implemented this year but the campaign group will keep the Parish Council informed.

5. PUBLIC PARTICIPATION

- The hedge which runs around the Village Green needs cutting. The Clerk will write to the current occupiers of the property to which it belongs.
- Are the Council happy for Cllr A Coldham to refresh the hanging baskets on the Village Green again? Agreed. Cllr A Ramsbottom will also refresh those on the Telephone Box in the warmer weather.
- Cllr A Coldham reported that due to the bad weather last week the Laurel Club lunch was cancelled and she received 3 queries under the winter scheme all of which were able to be answered.
- Thanks, were recorded to all of those involved with clearing the snow in the village – it was very much appreciated.
- Parking on Town Corner has been very hazardous recently – **please can residents be more considerate when parking.**

6. MATTERS FOR DISCUSSION AND DECISION

a. Finance

i) Accounts for payment

b. Herbert Phillip Fund

Still awaiting the outcome of the Parish Partnership bid and nothing more has been received from the Under 5's.

c. Memorial Bench in Lay-by

The person who raised this was not present at the meeting so it was agreed to defer discussion until the next meeting.

d. Grass cutting contract for 2018

The Clerk has only received 3 quotations despite now contacting 10 different people. Following discussions, it was agreed the contract would be awarded to A M Cultivating for this season and Councillors will look into the possibility of purchasing a machine / finding a driver for the future.

e. Royal Wedding Competition

Cllr A Coldham explained that the Laurel Club would like to run a competition for the Primary School children similar to what they did for the Jubilee. Would the Parish Council be prepared to sponsor the prizes as before? Following discussions Cllr A Ramsbottom proposed a sum of £50.00, which was seconded by Cllr J Norton and agreed by all.

f. Planning

The following plan was considered:

i) 20180288 – The Old Rectory, Cromer Road - No objections

The clerk gave an update on recent planning applications: 20172126 (Plot 1, 19 Brick Kiln Road) approved, 20172127 (Plot 2, 19 brick Kiln Road) approved, 20172201 (Park Farm House, The Wilderness, Shortthorn Road) approved.

g. GDPR Compliance Plan

The clerk circulated an Action Plan and suggested this is reviewed at the April meeting when all Councillors have had a chance to read along with the guidance document supplied by NALC. Agreed.

h. Greater Norwich Local Plan Consultation

All agreed the Council had no comments they wished to submit.

i. West Broadland Green Infrastructure Project Plan Consultation

All agreed the Council had no comments they wished to make.

7. MATTERS TO REPORT

a. Clerks Report

The Clerk provided details of the fourth and fifth sets of results from the SAM sign and suggested when all sites have 3 sets of results available, these are reviewed for any action. All results are on the Parish Council website.

The Clerk and Cllr G Crane attended the Allotment Training on the 27th February and we are doing what we should be, although there are one or two minor improvements that can be made. The allotment committee will meet later in the year to discuss.

b. Youth Advocate Report

The School will be coming to give a talk on recycling soon.

c. Village Hall Report

Hire rates are increasing from April by approximately £2.00 per hour.

Cllr P Carrick advised he has spoken to The Fox PH who have kindly agreed to donate funds from their bottle bank to the Village Hall. The Treasurer should contact The Fox PH to arrange. Cllr P Carrick was thanked for instigating this.

d. Police Report

The Clerk advised there were 3 crimes in the village during December and 2 in January. Fuller details are available on the website.

e. County Councillors Report

Thanks to the group who secured the decrease in the speed limit on the A140. The next step is to agree the exact start / stop locations at a site meeting on the 23rd April.

The Budget was passed by County Hall.

The suggested transfer of control of the fire service to the PCC has not yet been agreed.

The remainder of the NDR is still on target to be open for Easter. Lessons have been learnt for the future concerning bad weather. Although concerns have been raised regarding lighting on some of the new roundabouts, Highways do not consider there to be any issues at present. The preferred route for the second phase of the NDR is still being looked at so discussions around the financing of it and a start date is a good way in the future.

Cllr D Roper will reply directly to the resident who asked how a three-mile footpath can be put in at Great Ellingham for £60,000 as per the article in the EDP.

APOLOGIES

MINUTES

Minutes of the meeting held on 4th April 2017 were agreed by all and signed by the Chairman.

CHAIRMANS REPORT

2018 was the first time we have experienced snow for a number of years, when this happens it causes problems for motorists and heavy goods vehicles everywhere.

The trod path on Brick Kiln Road should be completed this year as the grant has been approved by Norfolk County Council Highways in partnership with Hevingham Parish Council. The Clerk will confirm a start date when she is informed.

A SAM sign has been purchased for the village and is interchangeable enabling it to be positioned at various points in the village.

The 50mph limit on the A140 will be reduced to 40mph, hopefully this will slow down motorists and make the road safer in the future. The road must be monitored with mobile speed cameras as this is the only way to ensure motorists stick to the speed limit.

The flooding just past the School is causing motorists and children coming from The Heath many problems. We must make getting this sorted our priority as it has been a problem for the past 2 or 3 years. District Councillor Paul Carrick and County Councillor Dan Roper must get together with the Parish Council to put pressure on the Highways Department to solve this problem.

The Church is still suffering with problems caused by the theft of the lead from the roof and porch but hopefully this can be resolved in the near future.

Finally, I would like to thank fellow Councillors, the Clerk and parishioners of the village for all their hard work and support.

ANNUAL POLICE REPORT

This item will be carried forward to the Annual Parish Council meeting in May.

MATTERS FOR DISCUSSION BY PARISHIONERS

A resident stated that Westgate is still flooding and causing problems. Following discussions, the Chairman advised that as Saffron Housing have completed the works they agreed to do, it is now down to the property owners to have their own drainage checked. Drainage on private property is a private issue and not something the Parish Council can get involved in. The ground cannot take all the water we have had lately but the road drains are taking the water away satisfactorily. Cllr A Coldham agreed to contact Age Concern on behalf of one resident to see if they can provide any assistance with getting the drainage on that property checked.

1. APOLOGIES

No apologies to note.

2. DECLARATIONS OF INTEREST AND DISPENSATION REQUESTS

There were no declarations of interest or dispensation requests.

3. MINUTES OF THE LAST MEETING

Minutes of the meeting held on the 6th March 2018 were agreed by all and signed by the Chairman.

4. MATTERS ARISING

The flowers agreed for the centenarian will not be required at present as there was a miscalculation in age.

5. PUBLIC PARTICIPATION

Cllr A Coldham asked why BDC were able to grant aid £1000 to help a resident of a nearby Parish to go to the Commonwealth Games when the Parish Council were not able to provide financial assistance to a resident of their own village a few years ago. It was stated that the Parish Council must adhere to the rules set before them and can only make payments under the Powers they are given.

6. MATTERS FOR DISCUSSION AND DECISION

a. Code of Conduct complaint (Cllr P Carrick left the room during discussions on this matter)

Councillors had been provided with details of this prior to the meeting and agreed unanimously to accept the findings of BDC that the Code of Conduct had not been breached. No further action is required.

b. Finance

i) Accounts for payment

The following accounts were presented for payment and were approved:

Cllr A Coldham (Hanging baskets for village green)	£60.00
P H Collins (1 st instalment on grass cutting)	£350.00

The Clerks standing order will be paid on the 5th April.

Balance at the bank now stands at £55,544.68.

ii) Hevingivers

The Clerk reported the Hevingivers have spent £198.00 of the fund they held from last year leaving £66.00 to carry forward with one event planned so far this year, which is likely to clear the £66.00 remaining. All agreed the group could retain the £66.00 for use this year with an update being given this time next year again.

c. Herbert Phillip Fund

The Parish Partnership bid has been approved. The Clerk and Chairman signed the necessary form to enable this to be sent with a cheque for 50% of the costs (£7100.00).

d. Memorial Bench in Lay-by

Following discussions all agreed the Clerk should apply for a license to enable a memorial bench to be installed. Cllr A Coldham will forward some possible funding options to those wishing to install the bench.

e. Farmers allotments centre drive

The Clerk has received complaints regarding the amount of mud being drawn onto the road from this drive and suggested the Council take action to stop this continuing. It was agreed the allotment committee, along with the Chairman, will meet on site to assess the situation and agree a plan of action.

f. Bus shelter

The Clerk suggested a 'window' be put into the side of the bus shelter to help those waiting, to see when the bus is coming and to also aid with ventilation. Following discussions, it was agreed an arrow type slot could be cut in so the Clerk will look into.

g. Royal Wedding Competition

Cllr A Coldham explained that when the previous competition was run only one class entered but this time the whole School will take part so 105 medals will be needed. Medals are £1.00 each but can be purchased for 90p each if 100+ are ordered. Following discussions all agreed to increase the donation to cover the 105 medals needed.

h. Planning

The following plans had already been considered:

20180369 – 35 Westgate Green – Majority no objections but concerns were raised regarding size, privacy and parking.

20180441 – The Gables, Low Lane – No objections.

The following plan was considered:

20180463 – August Farm, Brick Kiln Road – No objections

i. GDPR Compliance Plan

The clerks proposed action plan was agreed. Cllr P Carrick advised he was prepared to take on the role of Data Protection Officer and this was agreed by all.

j. Hedge cutting

The Clerk was only able to obtain 2 quotes for this but all agreed to appoint Zak Branch Ltd.

7. MATTERS TO REPORT

a. Correspondence

Norfolk Age UK have written seeking a donation. All agreed not to send anything on this occasion.

b. Clerks Report

The Clerk provided details of the sixth set of results from the SAM sign which will be printed in the next magazine.

c. Youth Advocate Report

The Youth Group is closed over Easter but numbers attending remain good.

d. Village Hall Report

The next meeting is on the 16th April so nothing to report now.

e. Police Report

The Clerk advised there were 3 crimes in the village during February: 1 anti-social behaviour (on or near Leonard Medler Way) and 1 anti-social behaviour plus 1 criminal damage or arson (on or near Pound Close). This information will no longer be put on the Parish Councils website but can be accessed via www.police.uk.

The Clerk then read a note from PC G Shepherd advising of his retirement in April and his replacement, who will attend the May meeting to go through the annual report. It was suggested and agreed that the Clerk send a letter in response.

f. District Councillors Report

Council Tax bills have now been issued.

g. County Councillors Report

Cllr M Williamson raised concerns over the new diy waste charges and how this is likely to increase fly tipping. Cllr D Roper advised he will be watching to see how costs increase for disposal of fly tipping against the savings made. Questions are being raised over the legality of the charge and how diy waste can be differentiated against normal residential waste to the extent some Councils who have already implemented the charge have now dropped it. Any payments made for disposal of waste will be given a receipt.

Cllr P Carrick questioned the progress of removal of the unauthorised bollards on The Heath but nothing more has been heard.

Next meeting is the Annual Parish Council meeting on the 1st May 2018 at 7:30pm in the Village Hall.


