PRECIS MINUTES OF THE MEETING OF HEVINGHAM PARISH COUNCIL HELD ON 8th JANUARY 2019 AT THE VILLAGE HALL

1. **APOLOGIES** - Apologies were received from Councillor's G Crane and P Carrick.
2. **DECLARATIONS OF INTEREST AND DISPENSATION REQUESTS** - There were no declarations of interest or dispensation requests.
3. **MINUTES OF THE LAST MEETING** - Minutes of the meeting held on the 4th December 2018 were agreed by all and signed by the Chairman.
4. **MATTERS ARISING** - The Clerk advised Highways have looked at the junction of Church Lane with the A140 Cromer Road and do not feel any action is required at present but will continue to monitor.
5. **PUBLIC PARTICIPATION** - A resident asked if the Council had any comments to make on the outcome of the GNLP discussions at the last meeting. Councillor's had nothing more to add but it was stated that they believe no more will be heard now until September. - Councillor's were then asked why they opposed development on Westgate but not The Heath.

Originally the land was sold to Saffron for 8 properties to be built on it but Saffron moved the houses to one side and are now seeking to put a further 8 on the site, which the Council feel is taking advantage of the village. County Cllr D Roper added that the number of houses built by Saffron were determined by the local housing need at the time and he doesn't think there is a need for any extra houses on the same site.

There is also the issue of flooding to consider which has been a problem ever since the first 8 properties were built. - It was asked why, when one of the duties of a Parish Councillor is to represent the local community, why the development on The Heath was supported when so many local residents were against it.

The Chairman responded that only 6 of the 31 residents present asked questions. County Cllr D Roper then added that there is a long list of sites and it will be a long way down the line before the new Local Plan is agreed.

Even if The Heath site gets into the new Local Plan, Planning Permission will still have to be obtained.

- A resident commented that Low Lane and Halls Corner are becoming extensions of the surrounding farms with verges being damaged by the farm vehicles, covering the roads with mud. County Cllr D Roper confirmed that Highways have an obligation to ensure 'safety' on the roads but otherwise 'clearing up' is down to the farmers. The Clerk has spoken to one of the farmers as New Road is also very muddy but the Parish Council have no actual 'power' to make the farmers clear up. It was noted that signs have been erected warning of mud on the road, but this does not solve the problem. Cllr D Roper and the Clerk will both refer to Highways again to see what more can be done.

- A resident reported damage to the speed limit sign on Brick Kiln Road as you turn in from the Holt Road. This area falls under Haveringland but the Clerk will report to Highways anyway. Damage was reported to bollards on the A140 Cromer Road on the left as you turn out of The Street. The Clerk advised she has already reported these to Highways.

- Councillor's were asked if they visited the development sites on The Heath before making their decision to support them. Some confirmed they did.

- A resident reported that the footpath on the A140 on the left heading towards Aylsham needs to have the bank cut right back as it is becoming very narrow. The Clerk will report to Highways.

- It was reported that the sewer works entrance on the A140 Cromer Road is a mess. The Parish Council have no control over this however the Clerk will see if she can make contact with someone to get it tidied.

- Cllr A Coldham stated at present she does not intend to stand again in the local elections in May as she did not join the Parish Council to be abused. All Councillor's are volunteers and do not have to stand for the sort of abuse that has been received followed the last meeting. Perhaps this will make room for others who think they can do better.

- A resident asked if a bus stop can be installed on the A140 Cromer Road at the end of Low Lane. It was felt this was unlikely to be agreed but the Clerk will refer to Highways.

- Complaints were received regarding potholes in the passing places on The Heath / Church Lane. The Chairman advised as these are unofficial passing places it is unlikely Highways will repair but the Clerk will refer to see.

- A resident asked if the speed limit on The Heath could be reduced so it is 30mph from the Holt Road, instead of half way down. County Cllr D Roper thought it was unlikely Highways would agree to this but the Clerk will ask.

6. MATTERS FOR DISCUSSION AND DECISION

a. Planning - There were no plans to consider and no updates to report.

c. Herbert Phillipo Fund Highways have confirmed they will shortly be starting work on the remainder of the trod path and the Clerk will be meeting with a representative tomorrow to make sure Highways plan corresponds with what was submitted under the Parish Partnership Bid – Cllr A Coldham will also attend.

Nothing more has been heard from the Under 5's.

d. Community Shop the Chairman advised he has been approached by Mr.Seales regarding the possibility of a community shop within the Cobble acre Park site. Initially Mr. Seales was just going to sell fishing gear, milk and papers to people using the Park but then it was suggested to him that maybe it could be expanded into a community shop, run by the Parish Council.

Rent would be payable and the Parish Council would be responsible for all aspects of running the shop. Cllr A Coldham reminded the meeting that several years ago there was talk of a shop in the Village Hall but this never went ahead for various reasons which she feels proves it would not succeed. In a vote all agreed it was not a suitable venture for the Parish Council to consider further. The Clerk will inform Mr. Seales.

e. Magazine editor -The Clerk has not been contacted by any one concerning this however Cllr A Ramsbottom advised she is aware of someone who is interested. Cllr A Coldham agreed to speak to the person in question to let them know exactly what is involved and if they are still keen to proceed, their details can be put into the spring magazine. If they do not wish to proceed the Clerk will place an article in the spring magazine asking if anyone is interested in taking this on. The deadline for articles is the 23rd February so the Clerk will need to know either way before then. All agreed the current contribution given for expenses can continue.

7. MATTERS TO REPORT

a. Correspondence - Nothing to discuss.

b. Clerks Report the Clerk provided details of the last set of SAM sign results which will be printed in the next magazine. All agreed a poster advertising a charity boxing tournament at AHS could be placed in the notice boards.

c. Youth Advocate Report -The group reopens this Thursday (10th Jan). Numbers have dropped off so they may go back into the School to promote to the new children.

d. Village Hall Report- Nothing to report. The next meeting is on the 14th January.

e. Police Report- The Clerk advised there were 4 crimes in the village during October: 1 violent/sexual offence (on or near Morgan's Way), 1 violent/sexual offence (on or near Pound Road), 1 vehicle crime and 1 public order offence (on or near Halls Corner). There were 2 recorded crimes in November: 1 vehicle crime (on or near Town Corner) and 1 antisocial behavior (on or near Benton's Way).

f. Reports -District and County Councilor Reports -Nothing to report from the District.

County Cllr D Roper reported that the current NDR consultation on 'the missing link' ends on Friday 11th January. NCC are committed to completing 'the missing link' and hope to start work in 2022. It is looking likely that the 'green link' will be the most acceptable option at this stage. The issues that were raised concerning the roundabouts on the new NDR have been worked on although signs that went missing overnight caused further problems.

Cllr D Roper hopes that when the speed limit on the A140 Cromer Road is reduced, people will be warned before it is completed and not just implemented overnight. (The Clerk advised it has been indicated to her that works will begin on this on the 18th February barring any last minute changes to the contractor's schedule).The mile cross recycling Centre is to be moved, possibly near to the A140 Cromer Road roundabout.

This site is larger than required so the Airport Park and Ride may also move to the same site. The decision on the children's Centre's will be made in 2 weeks' time.

Cuts have been agreed to the mobile library service which means unused stops will be lost and any 2 week service will become a monthly service. Hevingham is already monthly so this will not have a negative effect on the village.

1. **APOLOGIES** - Apologies were received from Councillor G Crane.

2. **DECLARATIONS OF INTEREST AND DISPENSATION REQUESTS** - There were no declarations of interest or dispensation requests.

3. **MINUTES OF THE LAST MEETING** - Minutes of the meeting held on the 8th January 2019 were agreed by all and signed by the Chairman.

4. **MATTERS ARISING** - The Clerk advised: - She is still waiting on a proper response from Highways concerning the mud on the roads as their first reply was that they felt no action was needed and the sign installed was temporary.

- The sign on Brick Kiln Road had already been reported and has now been replaced.
- The footpath on the A140 has been cleared and residents commented that a good job had been done of it.
- The pumping station entrance has been cleared.
- Highways have said 'no' to reducing the speed limit on The Heath as they do not have the funding available.
- No reply has been received as yet concerning the bus stop but the Clerk will pursue as residents felt that the new reduced speed limit has changed the dynamic of the traffic and a stop would not cause a danger.
- Highways have checked the passing places along The Heath / Church Lane and resolved what they feel is required.

5. **PUBLIC PARTICIPATION** - A resident reported tyres and rubbish in Buxton Heath car park. Cllr M Williamson will speak to Mrs. Jarvis as he is on the Hevingham Relief In need Charity who look after this.-

- Tyres were reported on Low Lane. The Clerk will refer to BDC.
- Tyres were reported on one of the farmers allotments. The Clerk will ask the tenant to clear
- Cllr A Coldham asked if the Parish Council would have any objections to a village picnic on Village Green on the 2nd June. All agreed they would not.
- Cllr A Coldham advised the village still have a defibrillator training course available to them and it will cost £22.00 to hire the village hall for this. Will the Parish Council cover this cost? Agreed.
- Cllr J Norton advised there are no '40' signs on Town Corner as you exit onto the A140. The Clerk will refer to Highways.
- Cllr A Coldham asked if the Parish Council would like her to refresh the baskets on the Green and triangle before she finishes as a Councillor. Agreed.

6. MATTERS FOR DISCUSSION AND DECISION

a. Planning - There were no plans to consider and no updates to report.

County Councillor D Roper joined the meeting at 19:50

It was agreed this should be paid by Direct Debit to ensure continued compliance and gain a small saving.

Cllr T Palmer proposed a donation of £30.00 to NARS, following receipt of correspondence from them which was seconded by Cllr J Norton and agreed by all.

All agreed not to continue with membership of the NPFA.

The Clerks standing order was paid on the 5th February and also today. It was noted that the Clerks salary will increase on the 1st April in line with NJC scales.

The Hevingivers have reported they still have £66.00 left from the grant of £1100.00 given to them in 2014. During the year they have held a coffee morning and garage sale and were able to give £4000.00 towards the church roof (£2500.00 of which was from the Parish Council).

The intention is to use the remaining £66.00 towards a barn dance on the 10th April although this will not cover the hire completely. The group have asked if the Parish Council are able to give any funding for this year. All agreed the £66.00 should be used towards the barn dance to clear the grant given in 2014 and then if further funds are required for other events, a new grant aid application will need to be made for consideration.

c. Herbert Phillipo Fund - The Clerk has heard nothing further from the Under 5's despite chasing. Cllr A Coldham suggested the Parish Council push them on their intentions and if the money is not going to be used, it is returned to the 'pot'. The Clerk confirmed she has already suggested this to them.

The work on the trod path has been delayed but the Clerk has been assured works will be completed and are now due to begin on the 18th March. This will mean another closure of Brick Kiln Road from the 18th March to the 5th April (19 days in total). Details have and will again be published in the EDP and the Clerk will place a notice on the boards but if residents can 'spread the word' so everyone affected is aware, it would be appreciated. Cllr D Roper commented that he did enquire if a total closure was necessary and was informed it was, due to the width of the road.

d. Training Policy An updated policy had been previously circulated and was agreed.

e. Grant Aid Policy An updated application form only had been previously circulated, as it was felt the Policy and Principles themselves were still relevant, and this was agreed.

f. Magazine editor - Cllr A Coldham advised she has been contacted by Tracey Matthewson concerning the magazine and she is happy to take it on with the help of her son. Tracey was present and said she would not need the 'expenses' but they could go towards the cost of printing, which she is prepared to look at doing herself.

All agreed they would like to see the magazine continue and so the Clerk will let Tracey have all the necessary information. The Clerk advised the Spring magazine is due to be delivered to her either Wednesday or Thursday and so will be with Councillors on Friday. The Clerk has also agreed with the vicar that Easter service cards for the Church can go out with the magazine this time.

7. MATTERS TO REPORT

a. Correspondence Nothing to discuss.

b. Clerks Report - The Clerk provided details of the last set of SAM sign results which will be printed in the next magazine.

- The Annual Parish Meeting will take place on the 2nd April at 7:30pm before the monthly Parish Council meeting. Any items for the agenda need to be with the Clerk by the 22nd March.

- Elections will take place on the 2nd May. Posters have been displayed on the notice boards, website and in the spring magazine. Anyone wishing to stand can obtain a nomination pack from the Clerk (email version only) or BDC (hard copy). Papers must be hand delivered to BDC between 20th March and 4pm on the 3rd April.

- The wayleave for the Broadband cabinet has now been signed and a copy retained by the Clerk.

- BDC has implemented a Public Spaces Protection Order throughout the Broadland District which requires those in charge of dogs to clear up after them on all land open to the public. The order came into effect on the 1st March. The maximum penalty for failure to comply with the order is £1000.00.

- The Clerk has a supply of 'No cold calling' stickers should anyone require one.

c. Youth Advocate Report - The group is currently closed until April due to a lack of volunteers to help. Numbers have also dropped off so they are having a big rethink on the future.

d. Village Hall Report The repair to the swing is still outstanding. The dog poo bin is going to be relocated nearer to the car park entrance.

e. Police Report - The Clerk advised there was 1 crime recorded in the village during December - violent/sexual offence (on or near The Turn. Further information can be accessed via www.police.uk.

f. Reports District Councillor - There will be no increase in Council Tax for BDC, no cuts and no savings to be sought.

County Councillor - A night road closure will be in place in the Shortthorn Road area of the A140 Cromer Road from the 20th May for 5 nights (7pm to 7am) for resurfacing works.

Council tax will increase by 2.99%. Children's Centre's caused a big debate but the request to put in more money was voted down.

The disabled threshold for help was decreased.

There was a proposal to cut Councillors expenses but that was not agreed and instead they were increased by 2%.

The budget meeting was delayed by 4 hours due to protestors who were eventually removed by the Police. A Cabinet system will run from May instead of the current Committee. The NDR consultation responses are being considered.

Next meeting is on the 2nd April 2019 immediately after the Annual Parish Meeting.

40MPH: Safety Campaign Wins **Speed Reduction.**

A group of local residents gathered together in October 2017 to discuss how to reduce the speed limit on the Cromer Road going through the village after yet another accident.

Social media had opened an almost instant reaction platform, specifically the 'Hevingham People' group on Facebook.

Many grumbled that 50mph was too fast. School children had to cross the busy road. The council had said the road was too narrow to put an island in the middle by the bus stop and no other traffic calming measures could be considered while the speed limit was 50mph.

Some thought it would take a fatality of a child before the council would take notice (although out of 62 accidents between 2012 and 2017, three out of thirty six people injured were fatal). That thought alone was enough to want to make a difference.

So Shane Ward invited people to attend a meeting to see what could be done to change the speed limit. Ten residents felt strongly enough to attend the meeting. Every one of them had a part to play in making a change for the better.

The research and data gathering by Anna Ellis was a crucial element to any challenge we were to present to the County Council.

Anna had gathered records of accidents going back several years, which would be precisely the information that the council use in their deliberations.

She pointed out that traffic had more than doubled in the last five years and with the expansion of housing in the area this would only increase.

Cars feeding into the Cromer Road had to wait sometimes up to ten minutes to join safely.

The Buxton / Cawston crossroads was particularly worrisome and pedestrians had to walk on the roadside between Hevingham and Marsham.

So the real number crunching groundwork had been done and it was brilliant evidence gathering, however, to make a winning argument we needed more than just data.

We gathered more information from the department for transport on village speed limits to understand where the council may be persuaded to agree with our view.

Hevingham village straddled the Cromer road with residences on either side; a minimum of 20 houses along the main road. In addition there were businesses and the village church.

The guidance for Hevingham could have been argued for a 30mph speed limit. At 50mph, many traffic calming schemes, like 'community Speed watch'. However, at 40mph the possibilities of introducing further measures were possible.

The council saw the Cromer Road as a main arterial road and would want to keep traffic moving. Therefore the campaigners agreed that the best compromise would be to argue for 40mph.

The campaign to reduce the speed limit between Hevingham and Marsham was launched late October 2017. There were many who supported it, although some announced that 'we tried it before and it didn't work'.

Dan Roper, councillor for Hevingham and Spixworth contacted the group to offer support and also to make us aware that there was another campaign for speed reduction through Stratton Strawless.

Dan helped us to shape the presentation to the County Council and advised on how we could strengthen our campaign.

We presented our campaign at the Hevingham Parish Council to ask for a letter of endorsement. We also contacted the Parish council at Marsham for their endorsement and also asked for support from Margaret McPhee, the church rector. Margaret not only wrote a letter of endorsement but also attended the council meeting when the petition was presented.

So we had data and government guidance that supported change.

We also had support from the local county councillor, and Parish Councils for Hevingham and Marsham.

But this would still not be enough.

A few voices calling for change, however legitimate, was not going to sway the council to agree with us. We needed to be many voices. We needed a petition.

The *Hevingham and Marsham Safer Road Campaign* petition gathered support both in paper signatures and an on line petition. The petition on line got 500 signatures in two days.

The final on line count at the end of four weeks was 1088. In addition we got several hundred paper signatures.

Anna organized some roadside signage to promote the campaign and also to create awareness from those who used the Cromer Road to travel. This was a lot of hard work that involved speaking to the owners of properties. Not everyone supported the campaign, which was to be expected. However, there was enough support to place a significant number of signs along the road from Hevingham to Marsham.

The County Council meeting took place in January 2018, when our petition was presented. We were ready to present arguments, albeit that we would have maybe a couple of minutes to state our case. However, the evidence that we had gathered and the support of over a thousand voices was enough at least in part.

The Council agreed at least to reducing the speed limit to 40mph through the village of Hevingham.

It was a partial victory but a significant one. We were not able to secure a speed reduction all the way down to Marsham village but crucially we had achieved what many thought could not be done.

It took another 14 months before the change took place, although we were informed in March 2018 that the work would not be carried out until the end of the year (financial year that is).

But there is more work to do. We dare to dream of a footpath / cycle path from Hevingham to Marsham and having a bus stop at the church end of the village.

While Marsham supported our campaign, it may be that they will have to be more proactive in order to make the stretch between Hevingham and Marsham safer for pedestrians and cyclists.

The response to the change has been positive. People say that it has become easier to join the traffic and crossing the road is safer. For others it has inspired the thoughts for other improvements like arguing for speed calming measures down Brick Kiln Road and also for safety measures around Hevingham School.

The question is, does it matter enough to put in the effort to make a difference? Hevingham now has a safer road because enough people wanted it, although it also takes the will of the community to come together in a common cause to make it happen.

Let's Tidy Up Hevingham!

Road signs, street names, road and path defects. You would think that the council would go around periodically and mend stuff. But it doesn't happen that way.

When I lived in London, we were able to use a web site called 'Fix My Street'. It was a simple application that took about 10 minutes to report a fault or defect. And it worked pretty well.

Well you will perhaps not be surprised to find out that Norfolk County Council does not use this technology and, in my opinion, have not gone out of their way to let you know what you can do instead.

So here it is...

Public questions at the Environment, Transport and Development committee asked what system did they have in place to allow people to alert them to defects. The reply was not only vague but was also unhelpful. So I did a bit of research and came up with this link.

So the norfolk.gov.uk website has a page you can go on to report everything from potholes to pavements.

I saw the sad looking road name 'Doctor's Hill' at the Brick Kiln Road end leaning forlornly against a bramble thicket. This is apparently the responsibility of Broadland District Council and their website does not show you how to report it. Further research revealed this is the place to go

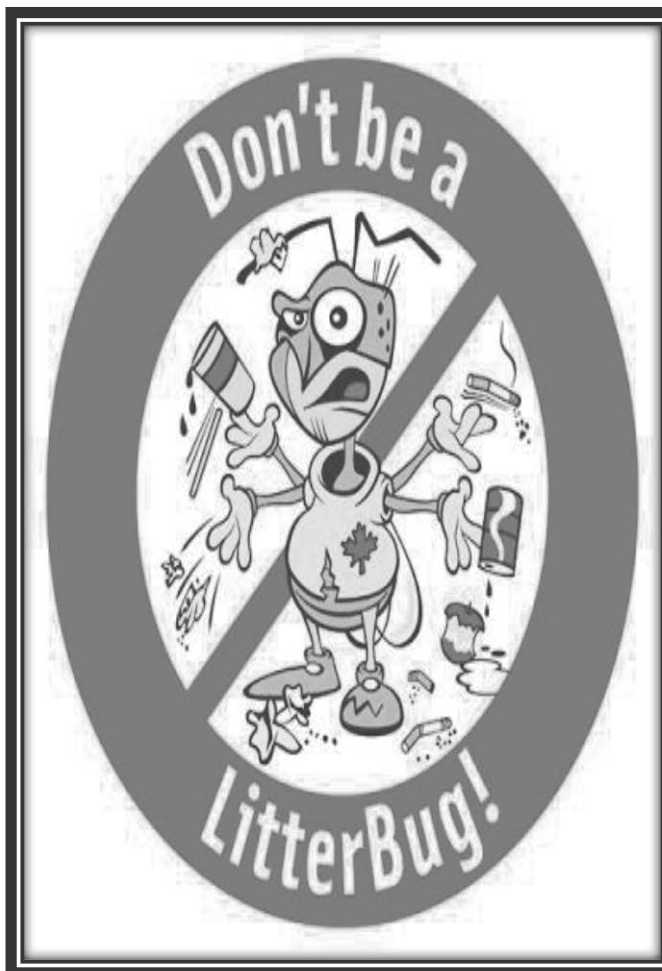

As the warm weather approaches taking to the water is a great way to cool off. Here are some tips to stay safe at the beach and in the water.

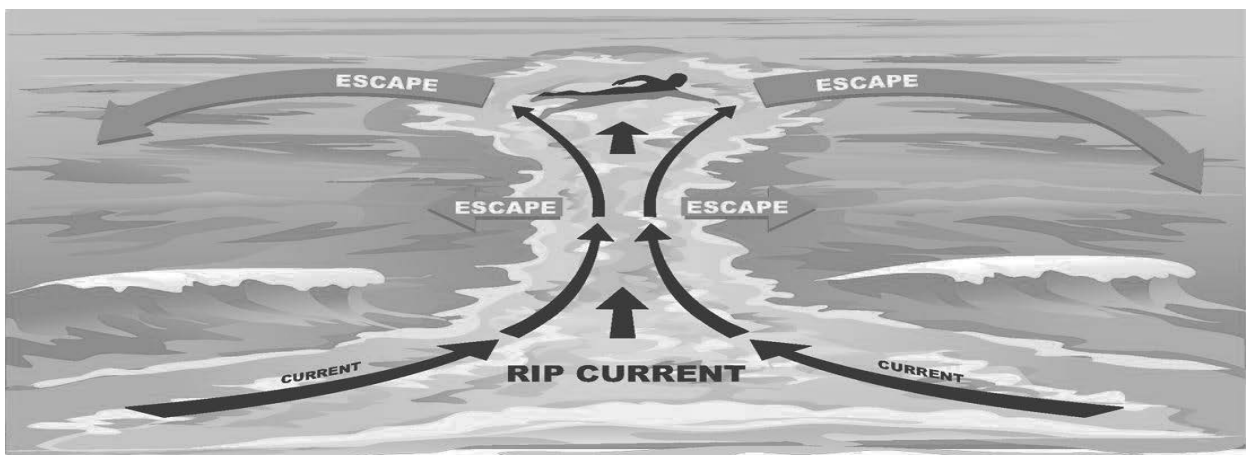


OPEN WATER SAFETY ADVICE

- Always check the conditions of the water and guidance signs, strong currents can rapidly sweep people away
- Do not enter fast flowing water
- Swim parallel with the shore and not away from it
- Avoid drifting in the current
- Be aware of hazards under the water. Not always visible
- If you feel cold get out of the water, cold water can make swimming difficult
- Never Drink alcohol and swim
- If possible wear a lifejacket, when boating or fishing
- Always swim in a supervised area and never alone
- If someone is in danger call 999 – if safe try to help the person with a stick, pole, branch, clothing or a buoyancy aid
- Don't swim in lakes, quarries, reservoirs or rivers
- Always provide children with armbands, rings, jackets or floats and never leave them unattended
- Always check water quality for toxins
- Always check the depth, uneven banks and riverbeds for dangers

IF SOMEONE IS HAVING DIFFICULTY IN THE WATER

- Shout reassurance to them
- Shout for help and call 999
- If safe for you to do so try and help them with anything to hold onto or that floats until help arrives
- Keep close eye on them and talk to them to keep them calm

The Church Roof Service of Celebration

All those who have been involved in supporting us, including the Hevingivers and the Grant bodies have been invited as well as the contractors and surveyor for the project. Do come along as we give thanks to God.

We've heard from Paul Bassham Charitable Trust who have given a grant of £1,000 towards the roof repairs for which we're thankful. We'd applied for this early in the autumn and so it releases the equivalent of the legacy for other church repairs.

Church Repairs

We'll be prioritising the repairs later in the spring. As you read this, the Church Surveyor would have met with myself and Mike Delph to establish the repairs to be made. I will let you know what is needed and costs. All this is to ensure the church can remain open and have a future, which we believe God wants.

We've been left a legacy of £1,000 specifically for church repairs. Our plan is to repair and make water and weather tight the door in the south of the Chancel area. We are currently getting estimates and will need to go through some legal processes before this can go ahead. We give thanks again for an unexpected amount which will lead to a repair to help us keep a bit warmer in cooler weather and the building a little bit more water tight!

You will all be pleased to know our churchyard maintenance continues to be undertaken by Mark Bedder. Mike and I have received so many positive comments for his work and sensitivity in looking after the churchyard and we're pleased he wishes to continue to work for us. 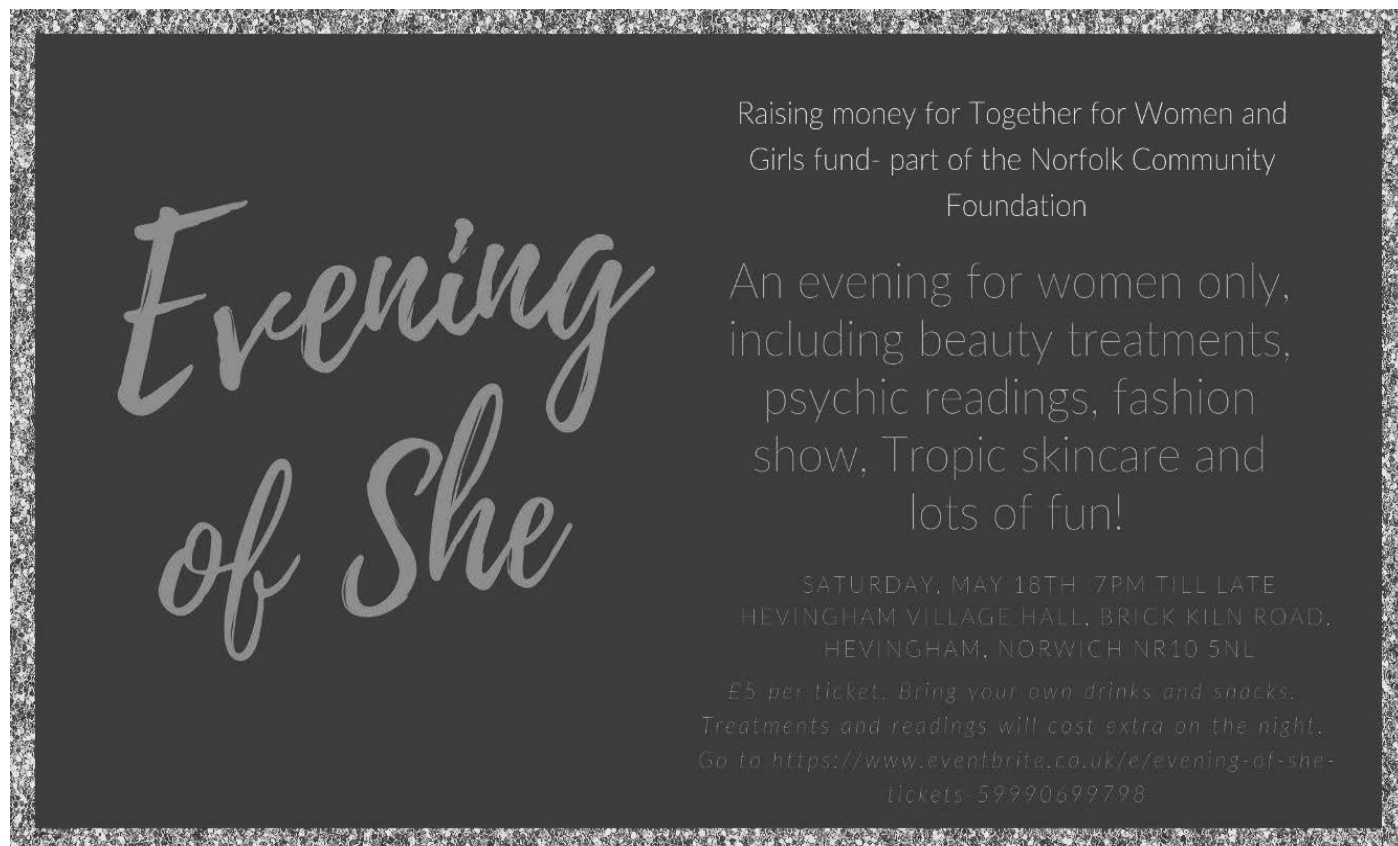
