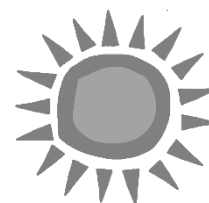


Welcome to the Summer Edition of the Hevingham News.

MINUTES OF THE MEETING OF HEVINGHAM PARISH COUNCIL

HELD ON 12th JANUARY 2021 ON SKYPE

1. APOLOGIES

Apologies were approved from Cllrs A Bunn, J Norton and T Palmer. No contact was received from Cllr A Ramsbottom.

2. TO ELECT NEW CHAIRMAN / VICE CHAIR AND NOTE CASUAL VACANCY RULES

It was noted that Cllr P Carrick resigned on the 7th January. Cllr M Williamson proposed Cllr S Ward step up as Chairman and this was seconded by Cllr D Holmes and agreed by all.

Cllr S Ward proposed Cllr S Benton take over as Vice Chair and this was seconded by Cllr I Nickalls and agreed by all. The Clerk explained that the public have until the 20th January 2021 to call an Election to replace Mr Carrick.

If an Election is called, the vacancy will stand until May 2021 however if an Election is not called, the Council can co-opt at their meeting in March.

Cllr J Norton has suggested to the Clerk that all Councillors may like to make a donation to a gift for Mr Carrick in recognition for all he has done over the years for the village and this was seconded by Cllr M Williamson and agreed by all. The Clerk will email all Councillors.

It was noted that Mr Carrick's experience will be missed.

3. DECLARATIONS OF INTEREST AND DISPENSATION REQUESTS

There were no declarations of interest or dispensation requests.

4. MINUTES OF THE LAST MEETING

Minutes of the meeting held on the 6th October 2020 were agreed by all.

5. MATTERS ARISING

There were no matters arising to report on.

6. PUBLIC PARTICIPATION

Councillors asked what progress is being made on having the fence removed at 'the beck'. The Clerk explained that she has chased Highways and NCC Boundaries Team numerous times but is met with no response. County Cllr D Roper advised he will take up with Highways tomorrow.

7. MATTERS FOR DISCUSSION AND DECISION

a. Finance

- i) The payments and receipts list is detailed at the end of the minutes due to its length. All payments were approved. The Clerks standing order was paid on the 5th November 2020, the 5th December 2020 and the 5th January 2021. Balance at the bank now stands at £41,976.65.
- ii) Following discussions and a vote it was agreed (5:1) to increase the Precept by the basic 1% only to £13,332.

b. Trees and hedging around Village Hall

It was noted that in between meetings the Handyman had advised he was unable to deal with the leaning tree due to its size and therefore following discussions with Councillors, the Clerk had appointed Mr Bambridge to deal with this. Also, it was agreed by all that Mr Bambridge should cut back all trees etc to a sensible boundary line, lift all lower branches and trim and mulch all rubbish and dispose of for the sum quoted of £900.00. It was agreed that obtaining further quotes was un-necessary.

c. Meeting Dates 2021

It was noted that these had been agreed via email in between meetings and have been published on the Councils website and on the notice boards.

d. Risk Assessment document

The Clerk had previously circulated a proposed amended document and this was agreed by all. It was also agreed Cllr D Holmes will step in for the Clerk should the need arise under Business Continuity. Cllr S Ward proposed Cllr D Holmes also take on the role of Councillor Auditor and this was seconded by Cllr S Benton and agreed by all.

e. Transport East survey

All agreed this was not really relevant to Hevingham and therefore no-one had any comments they wished to submit.

f. Herbert Phillipps Fund

Under 5's

The Clerk advised she has not heard anything further from the Headteacher. It was agreed the Clerk should contact the School again to see what the position is with supplying the invoice and also ask for some photographs or a video showing the completed works. If the invoice etc is not forthcoming the Headteacher should be invited to attend the next meeting to explain the situation more fully.

Trod path hedging

Thanks were conveyed to Cllrs S Howes and S Benton for planting the new hedging. Supports and guards have not been installed this time as the previous ones didn't seem to help. The hedge now needs time to take root properly.

g. Allotments

i) Updates

The clerk has purchased a combination lock for the second water tap which she will install shortly.

ii) New issues

- R Rolf advised the central road has now got several 'dips' in it and although they have been putting woodchips in to try to level it up, it really needs some hardcore. R Rolf was advised to speak to a couple of people in the village to see if they can provide some. Any costs will be covered by the

Parish Council. Cllr S howes offered to assist with 'whacking' the hardcore down.

- R Rolf asked if any funds are available for 2 bench seats to go in the orchard area. It was agreed there was so types/prices will be investigated. County Cllr D Roper suggested BDC may be able to provide a grant for those.
- Th Council were asked permission to install an L shaped storage box with a canopy over it, no bigger than the current sheds allowed, on plots 14 and 15. This was agreed.

h. Planning

All the following planning applications were considered in-between meetings:

20202110 – Chapel Corner Cottage, 47 The Street –

Detached single storey hobby room - No objections but would want to see the room restricted to use for a hobby room to avoid use for living accommodation.

20202215 – Slate House Farm, 27 Halls Corner Lane –

Conversion of existing barn and stables to 2 self-contained 2 bed holiday cottages – No objections.

20202245 – 47 Westgate Street – Erection of detached single storey cart shed – No objections.

20202288 – Kempton Park Farm, Church Lane – Erection of an agricultural livestock building – No objections but concerns about increase in traffic. (Cllr S Benton did not comment on these plans due to having an interest).

20202303 – 41 Brick Kiln Road – Single storey side extension – No objections.

i. Village Hall Playing Field Community Project

- The Clerk has obtained a copy of the conveyance and trust deed relating to the Village Hall which doesn't give much guidance in relation to this matter however the Clerk has spoken to Community Action Norfolk and circulated their advice to Councillors which was: As Custodian Trustees the Parish Council cannot do as they wish with the grounds – they have to work with the Village Hall Management Committee (VHMC) to make any changes.

As Custodian Trustees the Parish Council simply hold the title deeds and do not have any responsibility for the management of the Charity - this is down to the VHMC. Any decisions about what the Charity does can only be made by the VHMC and they are responsible for those decisions. For the project to move forward it was recommended that 2 councillors and a member of the public volunteer to be on a sub-committee (of the VHMC) to investigate and carry out this project.

The VHMC as a whole will need to have oversight of the project and make all decisions – this is not something the Parish Council can be involved in doing as Custodian Trustees.

It was agreed Cllr S Benton should arrange a meeting with the Chair of the VHMC to discuss.

- In terms of moving the project forward Cllr D Holmes advised they would like to get the garden area up and running first. The plans for the bike track need to be formalised which is likely to cost in the region of £500.00 but this cost would be deducted from the final invoice. Costs will be in the region of £20,000.00 to £30,000.00 but this could be reduced by local tradesmen doing the groundwork.

The 4 pieces of sports equipment will be £4,200.00 (fitted) plus flooring. The team are struggling to get feedback from the village at the moment but will press for some response.

- All agreed not to take out a membership of Community Action Norfolk for now.

j. Broadland District Council Overview and Scrutiny Committee

No-one had any topics to put forward for discussion.

k. Norfolk County Council Budget Consultation

No-one had any comments they wished to put forward.

l. Hevingham News

The editor had reported having some difficulties with delivery of the magazines to residents but the Chairman has since agreed, for the next edition, that they will be delivered to him and he will arrange distribution. This will be reviewed again in September because it is **all** Councillors responsibility to deliver the magazines as that was what was originally agreed.

m. Notice boards

The Clerk explained that the notice boards are deteriorating despite having had the Perspex replaced in them and she is now down to one key, which is rather soft. Some of the locks are stiff, despite being oiled and some are bent. The board on the allotments is also now broken.

Cllr D Holmes has obtained a quote to replace the boards and the Clerk has also circulated 2 other sets of prices.

Following discussions, it was agreed Cllr D Holmes will arrange replacement of the 2 boards on The Turn and The Green only (slightly smaller than quoted for) and all others will be disposed of as they were not considered to be necessary. Cllr D Holmes will dispose of all the old boards. It was also agreed R Rolf can arrange a board for the allotment site which will be more user friendly for the tenants, with any costs to be met by the Parish Council. The Clerk will ask the Handyman to cut back the trees/hedging near the board on The Turn and add this is the general maintenance schedule going forward.

7. MATTERS TO REPORT

a. Correspondence

- A resident has suggested the Parish Council should contact Cadent and seek some compensation for the village for all the inconvenience surrounding the works which have been going on for several months now and are continuing. All agreed the Clerk should do this. The Chairman reported the signs now up suggest the road is going to be closed fully from the 14th January to allow for further works to be completed.

- The Clerk has received a complaint about the amount of litter in the village and Cllr S Benton explained that she recently went out collecting some of it and was disappointed at how much she found.

Cllr S Benton intends to arrange another Litter Pick when restrictions are lifted as the last one had to be cancelled. The Clerk has reiterated the message about litter by putting up signs in the notice boards and also on social media. It seems that the litter is more likely to be coming from passers-by and visitors than actual residents.

b. Clerks Report

- The clerk provided the latest SAM results – full details will be printed in the Hevingham News. The camera will be left down for a while now to see what difference it makes.
- One of the farmers allotment tenants unfortunately passed away at the end of last year and so the Council will need to review what happens with the plots held at their March meeting. It was noted that the plots in question have become very run down and are not being used as intended.

c. Village Hall Report

Nothing to report.

d. Police Report

The Clerk advised she now has the recorded crime details from September to November:

There were 7 crimes in the village during September: 6 violent or sexual offence (2 on or near Park/Open space, 2 on or near Pound Road and 2 on or near Churchill Close) and 1 Criminal damage/Arson (on or near Westgate).

In October there were 2 crimes: 1 Public order offence (on or near Bentons Way) and 1 other theft (on or near Westgate Street).

In November there were 2 crimes:

- 1 drugs (on or near Cromer Road) and
- 1 Burglary (on or near Cromer Road).

e. District and County Reports

District (given by County Cllr D Roper on behalf of District Cllr J Neesam)

- There is a Council meeting on Thursday 14th January to sign off the consultation for the GNLP. There are no sites included for Hevingham although there are several for Aylsham so it will be worth looking at to consider if traffic / services will be impacted.
 - The earlier report published concerning the number of abandoned calls to BDC resulted in improvements being made and abandoned calls are now down to between 5-8%.
- County*
- Although the gas works are continuing, with a full closure of the road from Thursday, it seems the end may be in sight.
 - The Holt Hall closure will be going ahead due to the loss per annum of £60,000.00.
 - The Councils decision to make changes to the Minimum Income Guarantee for disabled adults has been overturned so many refunds are now being given.
 - The Budget will be agreed in February. Council Tax is likely to increase between 4-5%.
 - Unlike during the earlier lockdown, road maintenance is continuing, and the recycling centres are staying open.

8. MATTERS FOR FUTURE DISCUSSION AND DATE OF NEXT MEETING

Next meeting is on the 2nd March 2021 at 7:30pm and will either be in the village hall or online, subject to restrictions in place at the time.

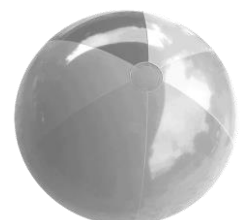

b. Herbert Phillipo Fund Under 5's

The Headteacher advised the Under 5's had opened in September 2020 and will be fully open from Monday 8th March 2021.

Things are going really well with several new local families joining and numbers growing weekly.

They are really pleased with the work completed to the roof, fascia's and guttering and the Chairman has seen this work.

The coating on the walls is still to be done but they do not have sufficient funding for this due to costs increasing for various reasons – for now the coating is watertight.

The Clerk is in receipt of a copy of the invoice for the completed work so it was agreed a cheque for 50% of those costs could be released (£5476.67).

c. Village Hall sign

The Chair of the Village Hall committee explained that several people drive past the Hall as there is no sign to highlight it so they would like to install a sign.

All agreed a sign could be installed in place of the notice board which is due to be removed. Cllr D Holmes will put together some designs and prices for the committee to consider.

The Chair also wanted to notify the Council that the office roof is currently covered by a tarpaulin due to a huge leak which has resulted in internal damage.

The whole roof needs to be replaced but they are having trouble getting quotes to replace it as it is.

A suggestion has been made to raise and reshape the roof with costs in the region of £4000.00. and all agreed they would have no objections to that being done but planning permission should be checked.

The Chair asked if the Council would be able to make a donation to the costs and was advised to seek other grant funding in the first instance. District Cllr J Neesam suggested the BDC Communities Team may be able to help with that.

d. Village Hall Playing Field Community Project

The project team had a successful meeting with the Village Hall committee who agree with the principal of the project but wanted clarification as to who would be responsible for the maintenance and insurance of the items.

The garden is the priority to begin with and there are three streams of funding available to help with this. Ongoing costs for this will be minimal.

The gym equipment will have some alterations made to it and its location will be changed so it sits between the play area and hedge whilst still maintaining access for emergency vehicles.

All agreed any maintenance and insurance costs for the garden area will be covered by the Parish Council with the others to be reviewed when more information is available.

The Chairman advised the Hevingivers are happy to collaborate with any fundraising.

e. Farmers allotments

The Clerk had previously circulated a draft letter to go to the deceased tenants known next of kin and this was agreed.

It was agreed re-letting of the plots will be considered at a later meeting.

f. Flooding in the village

The Chairman advised the flooding within the village has been the 'icing on the cake' with all the closures, diversions and potholes in the village. Once the gas works are completed, things will be better, but he believes there is enough of an issue to pursue these.

County Cllr D Roper suggested Councillors do a walk of the entire village to note all the potholes and report to Highways - this will be organised outside of this meeting and Cllr D Holmes will buy some temporary paint to mark which potholes have been reported.

The flooding on The Heath is being looked at this week. The regular ditch clearing is currently behind schedule, but they should be done in April – this will deal with Brick Kiln Road.

Highways should be chased again about the flooding on New Road near the School.

The sewerage flooding the A140 Cromer Road was noted and it is understood the leak has now been stopped just leaving the 'clear up' operation.

g. Allotments

i) Updates

- R Rolf advised Mr Oliver kindly donated some brick rubble and a gentleman in the village has put a lot of this down but the pieces are quite big so not really suitable for walking on. A bag of smaller material is available for £48.00 which may be better for making a walkway. Cllr S Howes proposed the Council purchase three ton of 'type 1', which he would be happy to help put down and compact, which would come in around £130.00.

All agreed Cllr S Howes should arrange, and Cllr D Holmes also offered to help.

- R Rolf advised she has looked into costs for some benches, and they range from £300.00 to £500.00. A grant was given by BDC for a polytunnel so she cannot go to them for the benches too. It was agreed the Council will cover the cost of the benches from the Herbert Phillipo Fund.

The Clerk will forward details of the Company the Council bought the picnic benches from to check their pricing.

- The posts from the old notice board can be re-used so R Rolf will just replace the top part with a suitable black board.

Rector's Ramblings!

Light at the end of the tunnel? We all hope so don't we as restrictions are slowly lifted. There are many of us desperate to get going to what was "normal" life and others who I have heard finding it daunting to go out again, to mix with people and visit shops and places dear to them.

Each of us are not only need to be aware of how we feel but also how others around us feel and think about "getting back to life". I have generally found people are more considerate and patient with others, and I pray we will continue to have these values at the heart of how we come across to others and the things we are involved in.

Marriage Registers Closed!

The Marriage Law in this country changed on the 4 May which has affected what I am able to do and record as the local Rector and what the church keeps as it's records.

The Church has been closely involved in witnessing and solemnising marriages since the 11th century, and from the Reformation parishes were required to keep written record of all those married in their churches, a requirement formalised in Canon 70 of 1610, which remained in force until the 18th century.

The Marriage Act 1836 provided for the duplicate green register books with which many of us are so familiar, and whose use came to an end on the 3 May.

For centuries it's been our privilege as a church, entrusted to us by the state, to keep these legal records of marriages. In these have been recorded the acts of loving commitment made by couples, witnessed by their friends and family and recorded on their behalf by our clergy.

Now the legal record of all marriages will be held nationally by the Registrar-General, but we shall still rejoice to welcome couples to marry in church and pray that God will bless and support them in their unions.

We have a new Register of Marriage Services where we will complete the details of the couple, both parent's names (not just the father's), occupations, witnesses and the clergy who conduct the wedding service.

So, the celebration will be recorded for the local church history and for descendants to research what happened.

Hevingham Church

As I write this the church building remains closed for Covid 19 secure reasons. I hope the building will reopen at some point in the future, I can confirm if you are planning to have a christening, get married and for future funeral services, they will take place in the building.

I am working with the PCC to secure a professional cleaning company who are respectful of and understand the historical nature of the place and its fittings so therefore will use appropriate cleaning materials. Obviously with our current income (minimal) this is a decision we are currently unable to put into action.

MINUTES

Minutes of the meeting held on 2nd April 2019 were agreed by all.

CHAIRMAN'S REPORT

2020 was an unusual year dominated by the coronavirus pandemic. The council, in partnership with our local charity The Hevingivers, quickly set up a support network during the first lock down and put together some emergency food parcels when people started to panic buy.

The village had 56 volunteers to help go shopping and pick up prescriptions. So, while the country experienced the worst of years, it brought out the best in people in Hevingham.

Due to the pandemic, council meetings were cancelled from April to June but business carried on where it was possible to do so.

Credit must be given to Tracey Matthewson who despite the lockdowns and restrictions still managed to produce the quarterly Hevingham News Magazine and our thanks go to her for her hard work and dedication.

Sadly, we have said goodbye to the Laurel club, as those who had run it retired and no one stepped forward to continue it. We must give a big thank you to the volunteers who gave up much of their time for so many years. In the future we hope some other volunteers may fulfil this excellent service.

The council played an instrumental role in keeping the under 5's building from disappearing altogether. Working with the Head Teacher of Hevingham school and also through the friends of Hevingham School, we were able to contribute to the necessary safety repairs so this important service to the local children might continue.

We must also acknowledge the hard work and commitment of Becky Rolf, who has worked tirelessly on the community allotments and encouraged people to take up gardening. Since she has become involved, not only are all the

allotments full, there is also a waiting list. It should be noted that after much discussion, we finally got a second tap fitted. We also purchased a new bench seat for the community allotment.

Our attention has also been drawn to some issues with the farmers allotments but these are ongoing, with a view to resolution over the next few months.

The village hall has been closed for some time due to the pandemic, although our thanks are extended to Julie Ella, who has committed to maintain the upkeep of the village hall and kept it ready for use. You may also have noticed that the village hall has new signs and the Parish notice boards have been upgraded.

The council agreed to take on the running cost of the surrounding village hall ground, updating some of the playground equipment, like the new swing, and covering the insurances. The council has some rather ambitious projects for the village hall grounds that we hope will appeal to villagers across all age groups.

This will include a gardening area and polytunnel, an adult gym to sit alongside the children's playground, a running / walking track around the outside and a BMX pump track at the bottom of the field.

Obviously, none of this is cheap and we will be seeking grants and other funding sources to realize the project. There will also be fund raising efforts via the Hevingivers when lockdowns are lifted and we can gather together socially once more. We hope that everyone will support these events as we try to improve the facilities within the village. The youngsters among us who would definitely want to use a BMX track have an opportunity to put your fund-raising thinking caps on and help us make it happen.

The council continues to undergo maintenance of the village for the benefit of the community and in doing so awarded a grant to the church for grass cutting and this year for tree maintenance. We have also employed a handyman for various ad hoc tasks.

There are some continuing issues that the council has yet to resolve, notably the flooding on some of the roads, one of which has been noted on the council minutes for more than 5 years. The flooding issue was further exacerbated by the gas repair on the corner of The Street and Cromer Road that was threatening to last longer than the pandemic.

Someone from Highways has come to inspect the state of our roads, as they did take quite a battering due to the main road closure. And although the council went on a major pothole reporting campaign, there are still issues to be resolved. We await the result of their findings.

For my sins, I was elected chair of the Parish Council during this year and hence I get the hot seat today.

I hope that moving forward, we, as a Council, can not only provide a responsive service to the Parish but also to make it more transparent and inclusive.

I have seen first-hand how this community can come together and make a difference and I hope we can encourage more people to become involved in service for the benefit of the village Hevingham.

MATTERS FOR DISCUSSION BY PARISHIONNERS

A resident had raised an issue via email concerning horses and vehicles in the village but this was not something the Parish Council could deal with, so she was referred to N.C.C. Another way of looking at this is that only 15 percent of vehicles go faster than this speed, and 85 percent go at or below this speed. The 85th percentile speed may vary slightly each time as this is based on the first 85 vehicles in 100 and is dependent on the speed that the vehicles are going through the sign. This is better than taking an overall average and it excludes the odd high speeders which would give false figures.

Drivers who exceed the 90th percentile have a significantly higher risk of crashing.

The Police use the 85th percentile speed to set speed limits and check they are appropriate.

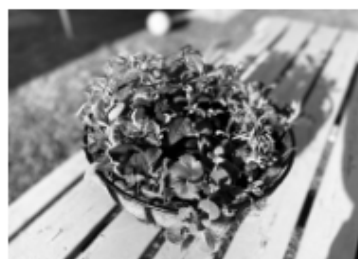

Prince Philip – Duke of Edinburgh. 10th June 1921 - 9th April 2021

We were all saddened to hear of the death of Prince Philip earlier this year.

I hope you enjoy our following article written by Suzanne Benton, sharing her memories of her experience and our favourite facts on his wonderful life written by Morgan Browne.

Memories of Prince Philip – Duke of Edinburgh.

Prince Philip was born in Greece on 10th June 1921. He was a Greek and Danish prince and his family exiled from Greece when he was 18 months old.

Prince Philip went to school in France, Germany and in the UK.

He joined the Navy in 1939 and served in the Mediterranean and Pacific fleets.

In July 1947 he gave up his Greek and Danish titles to become a British subject.

He also changed his surname from Glucksburg to Mountbatten.

Not long after on 20th November 1947, he married Elizabeth Windsor and they went on to have 4 children, Charles, Anne, Andrew and Edward.

Prince Philip was patron, President or a member of 780 organisations. The most well-known being the Duke of Edinburgh Award.

He was also the longest serving consort of a reigning monarch.

Prince Philip retired from his Royal Duties on August 2nd, 2017 at 96 years old and passed away on April 9th 2021 aged 99.

My Duke of Edinburgh Award Experience

At my secondary school (Watton) I was lucky enough to have a very committed team running the

Duke of Edinburgh award scheme. Mrs Elaine Hoggart (now Mrs Aberdeen) and Mr Tim Leonard.

These two, along with a supportive head teacher and other staff, paved the way to all candidates getting the best experience possible.

At fourteen, when I started my bronze award, I was asked to do a community service, gain a first aid award, pass a physical assessment in the school gym (running, sit-ups, rope skipping, etc), learn map reading and survival skills, culminating with an expedition in the Langdale Pikes in the Lake District.

We had old-style orange canvas two-man tents to erect on the field set aside for our large party. I seem to remember two coaches of us travelling up there.

The bronze, silver and gold candidates all went on the same week (activities week – near the end of the summer term).

The first day's hike was up to Stickle Tarn, climbing up beside a waterfall, being led by second year gold candidates.

Just as a side note, a few years ago my younger brother and myself decided to retrace our steps and climb up to the Ghyll to the Tarn.

We surprised ourselves by getting there in good time, then realised that we didn't have our rucksacks, so it was bound to be easier!

Aged fifteen I started my silver award and once again I took part in a community service – so at that tender age I became the fixtures secretary for my badminton club. That solved another issue; I had to follow a hobby for a year and write about my experiences.

Obviously, I chose badminton (dealing with two of the issues in one hit). More sit-ups in the gym, more running, just more of everything that I'd done in the bronze award, just to a higher level.

Again, another expedition week in the Lake District. This time culminating with a three-day unassisted hike in Borrowdale. Four girls, two tents, carrying all of our requirements for the trip.

Map reading became quite tricky in the awful conditions, but we managed to find our way along our chosen route.

Aged sixteen I started my gold award. Once again, more sit-ups, running, sport, community service (laying hedges in Wayland Wood every Sunday

morning for six months!). This time though we had to plan for a four-day unassisted hike; plan the route, cover the suggested mileage, take everything we needed with us in rucksacks. This was before the age of mobile phones, so navigation was something we needed to get right by using maps and a compass. I still love looking at maps as they have so much to tell you. I enjoyed every damp, sore, exciting, challenging moment of it.

By the next year (the second year of my gold award) I was at Norwich City College and it was harder to keep in touch with everyone, but I knew I'd be going on the Lake District trip again to help train the bronze awarders.

All of my efforts over the previous years culminated in a trip to Buckingham Palace to receive my award from the Duke of Edinburgh himself. I went in my knitted pink two-piece! I thought it looked lovely at the time. My friend Wendy and myself had been through the

whole experience together from bronze to gold, shared a tent, blocks and blocks of Kendal mint cake and many stories. Now we stood next to each other in the grounds of Buckingham Palace.

For two further years I would take a week off work and go with Elaine and Tim to the Lake District to help with the camp. I still enjoyed it and knew that my contribution was gratefully received.

I want to finish by saying the award scheme gave me a sense of adventure, community spirit and confidence in my own abilities. I am proud of what I achieved along the way to Buckingham Palace and wear my gold award badge with honour and pride.

To this day I am still in touch with Elaine and tell her often how grateful I am and that she really did inspire me.

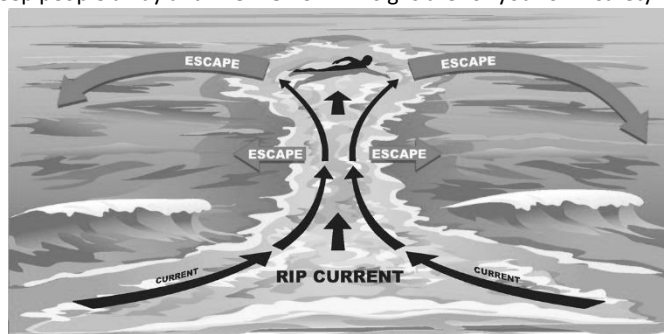


Open Water Safety Advice - *As the warm weather approaches taking to the water is a great way to cool off. Here are some tips to stay safe around open water.*

- * Always check the condition of the water and guidance signs, strong currents can sweep people away and 'DO NOT SWIM' signs are for your own safety.
- * Do not enter fast flowing water.
- * Swim parallel with the shore and not away from it. Avoid drifting in the current.
- * Be aware of hazards under the water that may not be visible.
- * If you feel cold, get out of the water as cold water can make swimming difficult.
- * Wear a lifejacket when boating or swimming.
- * Always swim in a supervised area and never alone.
- * If someone is in danger call 999- if safe to do so, try to help the person with a stick, pole, branch, clothing or buoyancy aid.
- * Always provide children with armbands, rings, jackets or floats and never leave the unattended.

If someone is having difficulty in the water shout for help and call 999, reassure the person, keep a close eye on them and try to keep them calm.

Help only if safe to do using lifesaving aids, pole, branch, clothing. Please do not put yourself in danger. Let's swim safely!!

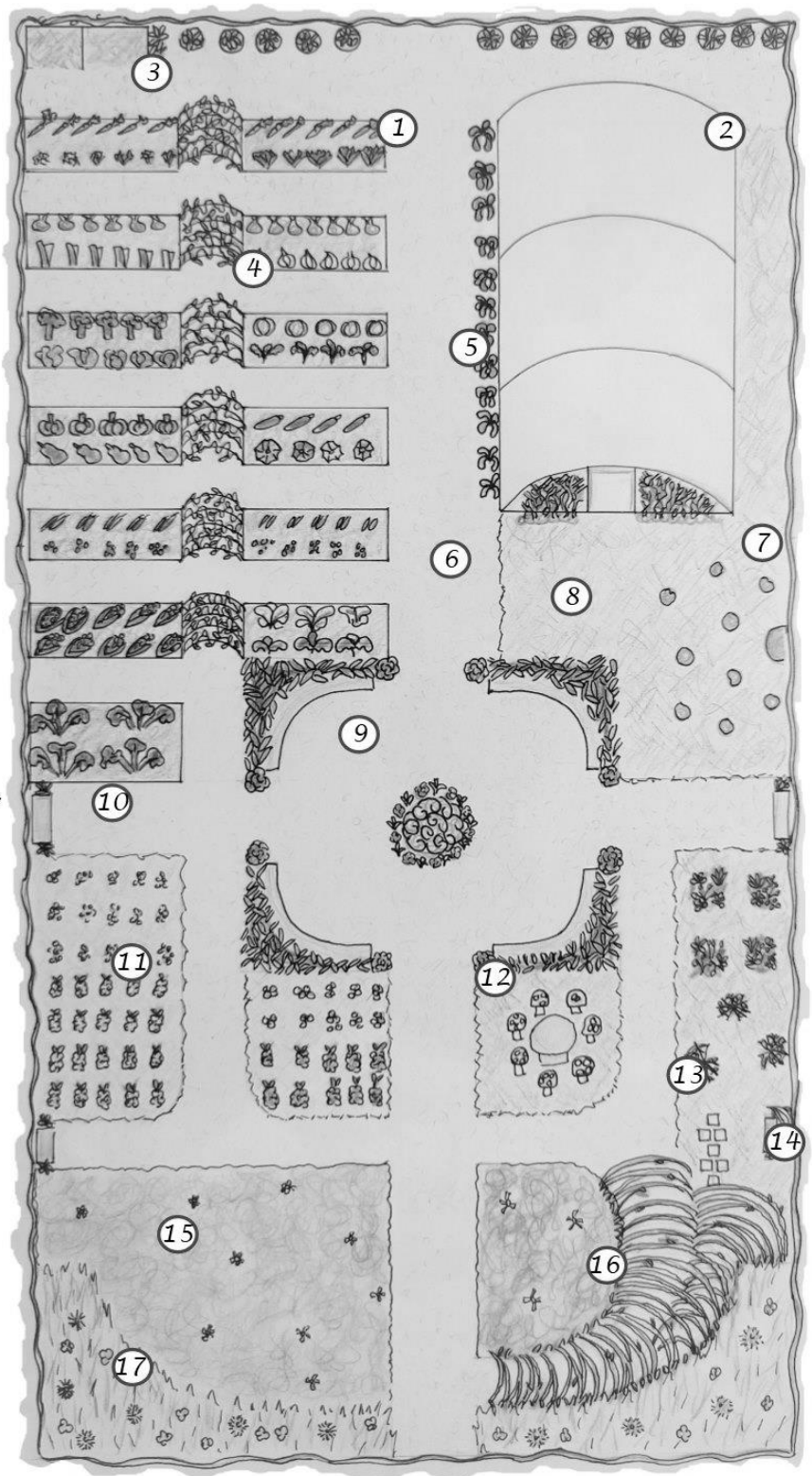
Hevingham Village Hall Community Kitchen Garden-

Phase 1 is the creation of the Community Kitchen Garden, to be located alongside the existing children's playground. We hope it will be a space that will be of benefit to many people.

To get it up and running it will need lots of helping hands! (Of all fitness/ability levels) If you would like to volunteer your time (even half an hour) this would make so much difference and help make it feel a community space right from the beginning! Within the budget is a portion for maintenance and free weekly and monthly gardening workshops, however, to get the project set up and running we need a LOT of helping hands! Becky.

- ② *Polytunnel*- Summer veg (tomatoes, peppers, cucumbers) Winter Salad and year round sheltered space for educational courses)

In early August 2020, we unfortunately lost a very much loved and valued member of the Aylsham High School community to a battle with mental health.

Formally known as Miss Hoggett, Mrs Cartwright lost her own battle with ongoing mental health issues.

As two past students of hers, Mollie and Ellie (alongside the help and support of Mr Spalding, Mrs Wiseman and Mrs Garnham), we wanted to organise something in which Mrs Cartwright could be remembered in a positive light.

Mrs Cartwright was very keen on running and regularly took part in the Blicking 5K park run - an event that provided the means to progress with her running with the added social aspect of running alongside friends and many students of hers.

We thought the perfect way to raise awareness of the importance of mental health and to remember Mrs Cartwright would be to organise a fundraiser event where former colleagues, students, friends and family could take part in a 5k run, jog or walk.

The event we have organised is called the 'Cartwright 5K' and will be taking place at Blickling Hall as a ParkRun on Saturday the 11th September 2021.

Although we would love to see as many people at Blickling ParkRun as possible, we understand that this might not be feasible for people who want to remember Mrs Cartwright living at a distance; you can take part via your usual ParkRun or your 5K route in any part of the world - we would love to see your photos of you taking part!

The money raised from our just giving page will be split between two places, one being the Young Minds mental health charity and the other being the TACT Families.

Young Minds have the vision of "A world where no young person feels alone with their mental health." With the mission to "To make sure all young people can get the mental health support they need, when they need it, no matter what."

TACT Families vision is to "support the social, and emotional, mental health and well-being of those children, young people and families in The Aylsham Community Trust Schools.

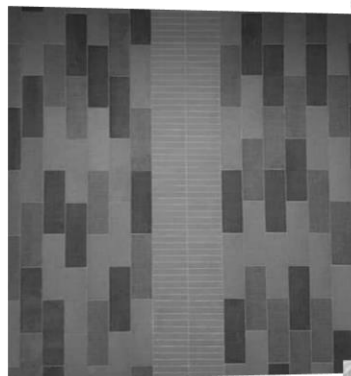

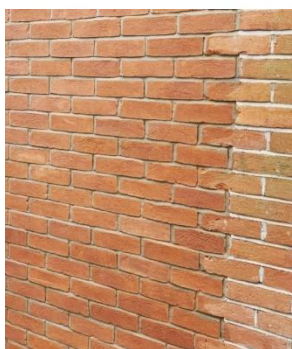
