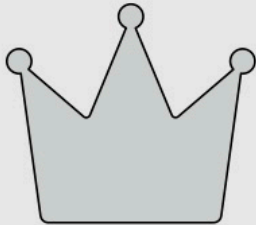
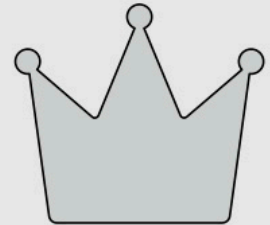

Editor's Comments

Have we arrived at the 'New Normal' yet or are we still experiencing Omicron (and on, and on...)? At the time of writing it is surmised that the Omicron variant burns brightly and then fizzles out almost as quickly. What it means to us is that so many people get the virus that there few left to be infected. Are we finally to see the end of the coronavirus pandemic?

Welcome to the Spring edition of Hevingham News. I had rather hoped there would be a rush of volunteers to pick up the mantle of village magazine editor but I have to say that there have been no enquiries about any of the volunteer posts. So I have placed the list again, unchanged, in the hope that the previous article might have been overlooked and there is yet someone within the village with a passion for their community and a willingness to become involved.

In this quarterly issue we plan for the Queen's Platinum Jubilee celebrations. Elizabeth became Queen on 6 February 1952 and plans for celebrating her 70 years will take place in June. The government have moved the late May Bank Holiday to Thursday 2nd June to make a four-day celebration.

On Thursday 2nd June there will be a parade for Her Majesty, the Trooping of the Colour, along with the lighting of beacons all over the country. The Parish Council did discuss whether we wanted to purchase a beacon (or indeed light a fire as some parishes may be doing) but considering our supposed commitment to reducing our carbon footprint and tackling climate change, it seemed wrong to start buying gas fired beacons that would be used only once; if indeed we could afford to buy the gas by June. What we will do instead is proposed in the

article explaining our plans for the celebration.

On Friday 3rd June there will be a thanksgiving service held at St Paul's Cathedral in London.

On Saturday 4th June there will be a party at the Palace with a special televised concert in the evening.

On Sunday 5th June there will be the 'big lunch' where people will hold street picnic parties as a community. I am old enough to have memories of long trestle tables, bunting and lots of finger food at the Queen's Silver Jubilee in 1977. This was an era where there were no computers, no mobile phones and only 3 channels on a colour TV (quite possibly rented as they were so expensive at the time).

So there are plans to hold our very own big lunch at the Hevingham Village Hall. There is a committee of volunteers and proposals of what we would like to do will be outlined in an article later in this magazine; so no spoilers here but I have judiciously commandeered the front page to give you a heads up that we are planning something special for Hevingham.

Finally just a quick reminder that the clocks go forward on 27 March. Let's hope that by then the pandemic will become endemic as we head towards warmer and brighter days.

Volunteers . Volunteers . Volunteers

Communities come together when there is a common need and people are willing to give up some of their time for the benefit of providing that need. Without willing volunteers, the need goes unmet and there is one less opportunity to bring the community together under a common purpose.

For example, your Parish Councillors are volunteers, albeit that they are elected to represent the Parish and to make decisions on their behalf in maintaining the village and introducing improvements for the benefit of the community. The next Council election is 2023, so if you think this role is the one for you then you will have the opportunity a year's time.

There are other roles in need of organisers; someone or several someones prepared to take charge or to form a committee. This may take only a few hours out of your busy life. Committees meet around an average of 4 times a year to a maximum of 8 times a year for a couple of hours. This is 16 hours a year maybe! So here are the opportunities for you to make new connections with people in the village and do something that benefits the community at the same time.

1. Magazine Editor

The magazine editor works closely with the Parish Clerk and Chairperson to produce a magazine four times a year. The editor's role is to collate the Parish Council minutes, articles and advertisements into a 28 page presentation. The editor's responsibility is to fill the advertising spaces and to invoice the advertisers. Also the editor provides the printer with a copy in PDF format two weeks before the publication dates, which is the first week of March, June, September and December.

2. Tots group

There was a Tots group but there isn't one anymore. Mums were able to meet up once a week at the village hall for group play and a chat. Obviously this is a role for mums with little ones. At least one person has to pick up the responsibility of building this essential community connection.

3. Church Council

St Botolph has to have council members to look after the building and keep it looking nice for worship. Those who did this role are retiring. Without a council, the church will only be available for hire. Interested volunteers to contact the Rector Rev Margaret McPhee.

4. Hevingivers

Committee members needed to help make decisions on where the village benefits, or where an individual may benefit and there is no other means or resources to make it happen. Hevingivers have helped children with serious medical conditions, raised money for repairs to the church roof and to the village hall play equipment. They organise fund raising events like bingo nights, therapy days and garage sales. Interested volunteers to contact Sharon Ward on 755314

5. **Laurel Club** is no longer operating. They used to cook meals for the elderly at the village hall until the cook decided it was time to hang up the apron. We welcome new ideas to replace this community service but there was quite a commitment to this venture and many volunteers to make it work. Rector's Ramblings!

When did you see the first Easter eggs? I guess seeing the first Easter eggs in shops on the 27 December was just a bit too much for me; they even beat Valentine's Day! It seems no sooner have we past one major celebration, then we're onto the next one.

With this magazine you'll receive the Easter card with details of the services in the week leading up to the amazing celebration of new life. Christians believe Jesus rose from the dead on the first Easter day and it is this that brings hope, joy and faith. The essence of this "love story" is a culmination of a week Christians call Holy Week. Starting with the celebrations of Palm Sunday when Jesus rides into Jerusalem to cheering crowds to the private, personal meal, The Last Supper, with his friends the disciples and the agony of the night in the garden of Gethsemane where Jesus was arrested. A show trial followed before he was killed in the most brutal way on a cross. Despair and grief along with fear followed until that first Easter morning the women discovered Jesus had gone from the rock-sealed grave and they see him alive in the garden by the tomb. The rest, as they say, is "celebrational" history.

Rural Dean

piece of music for the occasion, which I was so touched by, and it was a joy to have friends and members of congregations from across the Deanery come along. A Rural Dean is to be aware of the circumstances of the Parishes across the Deanery (this includes Drayton, Hellesdon, Horsham, Spixworth, Sprowston, Taverham, New Catton, Old Catton, Mile Cross...!), to support clergy colleagues and to Chair Deanery Synod (a meeting of clergy and elected lay people) plus anything else the Bishop may ask a Rural Dean to do! It will be a privilege to serve.

The Church Building: the future

The Church Council have agreed St Mary and St Botolph Church should be transferred to the Diocesan Churches Trust. I am now in the process of working with the Diocese to see this process through. We are at Faculty stage which is the legal application process. Once that is completed, I am expecting approval for the transfer. It is likely to be around 3 to 4 months' time. As I mentioned in my previous article, I will keep you posted on social media and via this magazine.

What does this mean for you, the Parish community of Hevingham?

A minimum of 6 services a year at the church. 3 of these will be annual:

- a service around Easter,
 - Remembrance
 - In the lead up to Christmas.
 - In additional christenings, weddings and funerals will continue to take place. These should be booked with myself as currently.
- The building will be maintained i.e. kept in repair for use, and insured by the Trust
 - Cleaning of the church can be arranged in preparation for a christening, wedding and funeral service. This will be done by the recommended cleaners for churches (and other ancient buildings) ensuring only those cleaning products suitable for grade 1 buildings are used. The cleaning charge, which is paid in addition to the specific service fees, for 2022 is £375.
 - The churchyard can be left to be a wildlife haven, or, as the Parish Council have indicated they would like to do, be maintained.

Up to the end of last year the Parish Council kindly paid 100% of the maintenance of the churchyard for us, for which I and the Church Council, as well as the wider community, I am sure have been really pleased with the current contractor who has done a fantastic and sensitive job over the past 3 years. How do I know, because so many of you have told me and I haven't had a single complaint!

The Churchyard

This is an amazing place to visit with the wildlife, trees and flowers all giving a sense of peace and refreshment. As I write this the snowdrops are out with a beautiful carpet of flowers.

The churchyard itself is almost full. The Church Council is at the early stages of the process of working towards its closure. When it closes it means, unless someone has a reserved space confirmed by a Faculty (the legal document) or is being laid to rest in an existing family grave, no more burials or interment of ashes will be able to take place. There are plans to open up a new churchyard which run alongside this process. Again I will keep you posted. In the meantime if you wish to reserve a space whilst the existing churchyard remains open, do contact me at revmargaretmcphee@gmail.com or 01603 893108.

NEW SIGNS

In 2021, the Parish Council were asked if the village could have signs that said to slow down for horses. Hevingham is reported to have around 117 horses who may access some of our roads.

However, the never plea for drivers to slow down, especially where there is a horse and rider using the road, even though it is now written in the revised version of the Highway Code, it seemed only right when considering the safety of our villagers, that we should include animals as well.

The request was made at a time when Highways were looking to reduce signs rather than put more up. But that didn't mean we should just give up, or that this was the only way to achieve our goal.

If Highways were not going to help, there was a solution but it involved the willingness of villagers to put up signs on their own land. So I am happy to say that the five signs the Parish Council purchased have homes and by the time this magazine is issued they should all be put up. There will be two on Brick Kiln Road and three along the Church Lane / Heath road.

Thanks for permissions to Pam Norton, Richard Pointer, Suzanne Benton and Derek Giles for allowing us to achieve something that hopefully will be of benefit to the whole village. The final sign is destined for the Farmer's Allotments.

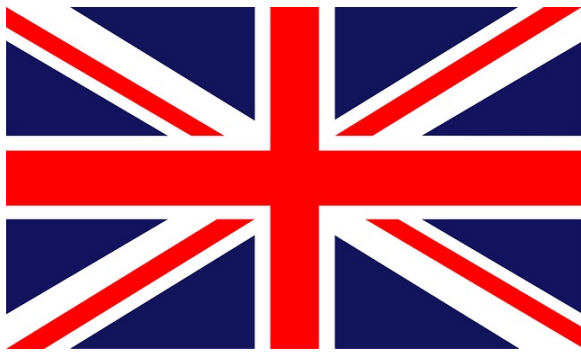

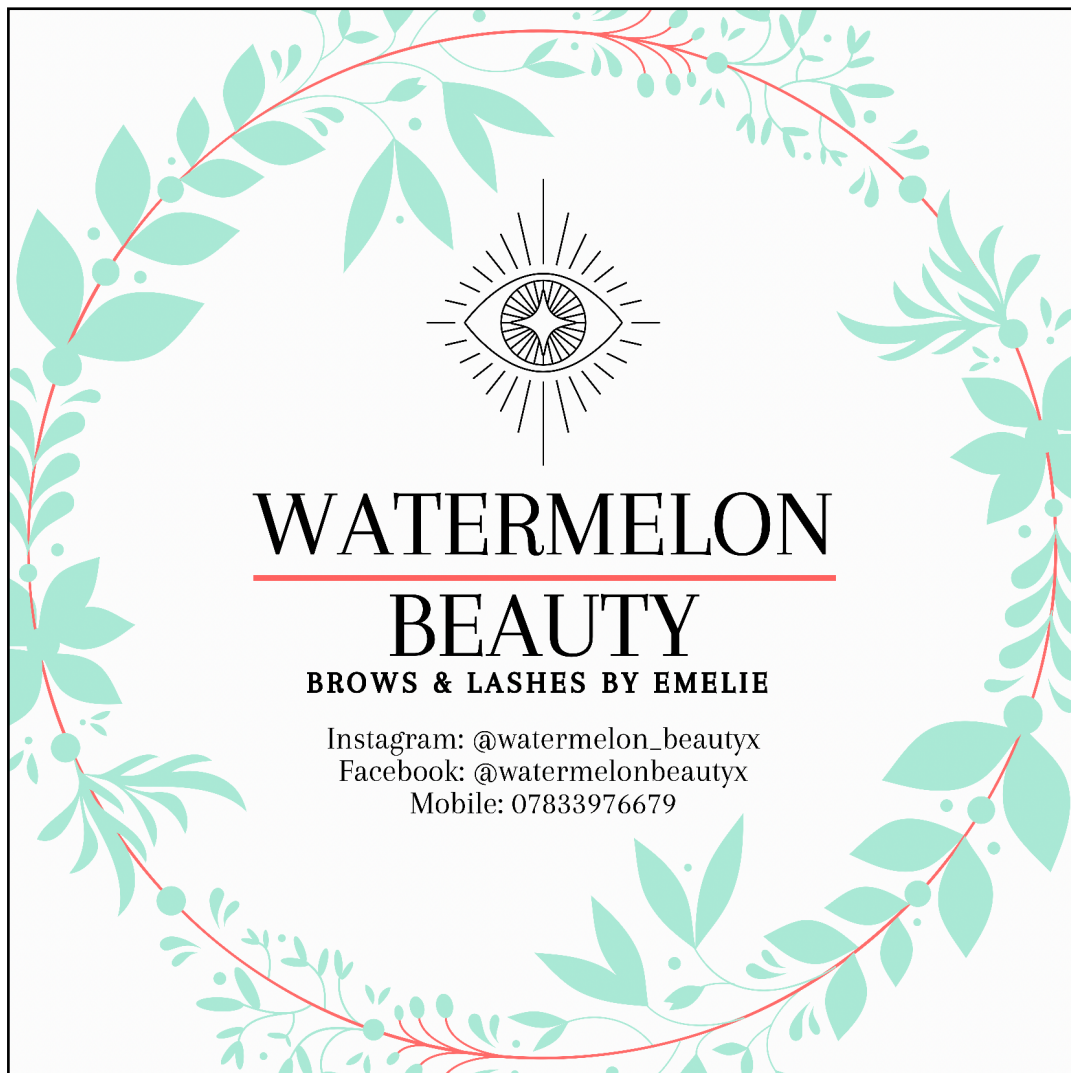

Public Rights of Way - Footpaths

- You may or may not know that Hevingham has nine footpath public rights of way and I have not walked one of them; an omission I plan to rectify. But there may be many of you who use some of them regularly. If you are familiar footpath walker, please do get in touch with the Chair of the Parish Council.
- Once upon a time there were people who used to walk the footpaths to see if they were in good order and devoid of obstructions. This paid position appears to have become obsolete along with the knowledge that they even existed.
- Some of the footpaths appear to be no more than short cut-throughs but a few appear to be a mile or so long. It would have been nice to put a copy of the ordinance survey map here to illustrate where they are but unfortunately it is copyright and says that no copies can be made.
- However, you may view almost all of the footpaths on the website footpathmap.co.uk

- The challenge for this year will be to walk all nine footpaths and using the online application 'what-three-words' to record an up to date identification of the beginning and end of each footpath. Looking For New Members

Having lived in the village since 2005 I am surprised that so few people are aware that they possibly have the best scale model racing circuit in the world but definitely the best in the UK here in their village. I have raced on many tracks in the UK but 'nothing even comes close' to Presto Park.

The track is a four lane, 97 ft to the lap circuit with an electronic digital lap and time recording system. The lap times are accurate to within 1000 th of a second, the current fastest lap having been recorded at 5.546 seconds. The circuit is fully landscaped with over 150 trees and over 1400 figures around the track. The circuit and all buildings can also be illuminated as we run some races in the dark every year. The circuit has a heli port with the landing area illuminated too.

We run several different classes of cars including Sports/Gt, NASCAR, Saloons, Goodwood and Formula 1. We run cars made by Scalextric but they are heavily modified to make them perform better and be more reliable, something that Scalextric still haven't managed to achieve. The cars we run are mainly made in Italy, and whilst being slightly more expensive than Scalextric are superb.

Comparing this hobby to many others it is relatively inexpensive. Once you have your cars and hand controller it is just replacing tyres and pickup braids that are required. When you join the club training is given to help you prepare your cars and assist with how to drive these rocket ships. However, we don't expect you to buy everything straight away so hand controllers and cars will be loaned to you for a few weeks and second hand equipment is always available to get you started. Once you get into the hobby you will want to upgrade to the latest cars etc.

Slot car racing as it is called is very addictive, I have been racing since i was twelve years starting with a figure of eight track on my parents lounge floor, I am of the age now when I draw a pension.

ii) Following discussions and 2 unanimous votes, it was agreed: 1 - the Clerk should make the necessary arrangements so the Parish Council can move to Online Banking. 2 - Cllr M Williamson will come off the account as a signatory and be replaced with Cllr D Holmes.

iii) The Laurel Club will be holding a Community Thank You Lunch for their cook and have asked if the Parish Council would like to attend and make a donation for a gift. It was agreed that the Chairman will attend and take a £30.00 garden centre gift voucher so the recipient can choose her own plant. A cheque was made out to Cllr S Benton so she could purchase an appropriate voucher.

iv) The Church have requested further funds to cover the grass cutting for this year due to extra cuts being required. They currently have £43.75 left from the original grant given but are looking for a further £631.25 to cover the September cuts and possibly another £225.00 to cover October. Following a lengthy discussion, the

The Council has a new policy on promoting the use of electric vehicles. This includes making a bid for government funding towards provision of charging points at community hubs, village halls etc. If successful, the government funding would cover 75% of cost with the remainder coming from my local member grant. This will be something to consider if the Council bid is successful.

Ofsted are doing an inspection of children's services this week.

Usually, the Council would be kicking off its budget process, but everything has been delayed for a month whilst we wait for news on government funding. You may have seen the government plan to raise NI to fund the NHS and Social

Care - we wait to see whether the government will go through with this and also how much of the social care money actually finds its way to local councils.

What is a precept?

Some things you take for granted because you always do them and they become second nature. For example, once we establish the days for our refuse collection, the habit of taking the bins out on certain days becomes an unquestioned part of the everyday pattern of life. Fifty years of London life and 'London-centric' thinking had to be changed when I moved to Norfolk. I had no experience of oil fired heating or septic tanks for starters. I also had no experience of Parish Councils (because there were none in London) or how they worked.

In my first year of living in Hevingham, attending the Parish Council meetings, was the first time I have come across the word 'precept' and had no idea what they were talking about. So what was a precept and how did it fit into village life?

If you look up the word by itself on the internet it won't help much unless you also add

'local government' to the search. Then it defines precept as: "...the parish council's share of the council tax", except that it goes on to say it is an amount in addition to the County Council's demand for Council Tax. The next question therefore had to be, what is it for?

The Parish Council is responsible for maintaining facilities that it creates, like allotments, property and anything the County Council is not obliged to look after. If the people in Hevingham want something that the County Council will not provide, it is an expense that must be met purely by the people in Hevingham. The amount of the precept and how it is spent is decided and managed by your elected Parish Council. The amount that each household pays is decided by a system that calculates the cost of a band D property and the number of properties in the village. Hevingham's number in 2022 is 424.

The precept for the year 2021 was £13,200 (£31.13 per household if you divide the precept by 424), so in addition to your council tax from County Council there is - on average - an additional £31 to pay.

What does the council spend the money on?

Each village has its own facilities that are enjoyed almost exclusively by them. Hevingham has the village hall grounds and a village green that has to be maintained. It sometimes seems that council meetings are dominated by grass cutting - and indeed we also have supported the maintenance of Hevingham church churchyard because it is used so often. But there is also the maintenance of trees, hedges, street lighting, electricity, a handy man to do odd jobs, the village magazine, councillor training, subscriptions and general maintenance around the village.

Most parish councils have an annual precept but Hevingham has one of the lowest precepts in the Broadlands District. At least one parish has a precept of £129 and there is no limit on how much a council is able to set; however, it really depends on what facilities a village wants that decides how much it would have to pay to get it.

In 2022, with the price of everything going up, the Parish Council had no choice but to increase the precept. However, we were aware that the County Council were also going to raise the council tax by 3%, so while the increase to £15,000 (£35.37 per household) would not cover the projected expenditure the Parish Council had to acknowledge the need to make savings as well.

Ivy Venables 100 years old

So how much life has a 100 year old seen in their lifetime? Ivy Venables, having been born in the East End of London in March 1922, has seen plenty. She left school at the age of 14, even though her teachers thought she should have stayed on. It was a financial necessity to get the children out as early as possible to earn money for the family.

She was May Queen in her last year at school, something we know she was very proud of. Dressed up in a pretty white dress she remembered it fondly, especially as she wasn't able to find one in time for her own wartime wedding, which took place while her husband was on a short leave between operations.

Her first job at 14 was in the City of London in the office of a paper distributing company, which she loved; until she applied to join the Land Army and was billeted at Nazeing, near Epping Forest, working there through most of the 2nd World War.

She got married to Gerald (knew him since school time) during the wartime in 1944 just before he flew out to Arnhem. He was a glider pilot and landed in Holland where he was captured and taken prisoner as a wounded soldier.

While he was missing and after narrowly escaping death herself from a doodlebug (V2 bomb) which landed on her bed when she should have been in it, Ivy decided to go and live with Gerald's parents in Ross on Wye and joined the British Red Cross there, working with young children. Shortly after that she got a job as a nanny after being highly recommended to a family whose father was significant in starting up the National Healthcare system and was mainly living on their estate in the Isle of Skye.

So for 6 months Ivy did not hear anything from her husband and immersed herself in her new role as nanny. She loved it; In fact, when Gerald did finally get home from the war, the family begged Ivy to stay with them. But Ivy wanted to start her own family and made the decision to leave and start her life as a wife and mother.

Family was always a priority in Ivy and Gerald's long married life and they had a very large one: 6 children, 12 grandchildren, 18 great grandchildren (at the last count) and many children fostered by 4 of her own children too. She was mostly a very busy housewife until all of her children were at high school, when she then worked as a school secretary in a London school. Loving her job, working in the school and amongst children again, she was a little upset at having to retire. Gerald bid on a house at an auction at The Bell, Norwich and unexpectedly bought a house in Hevingham in 1984. Their son Mark, who had just bought a house in Nelson Way, saw this house up for auction and got his parents on a whim to come up from London to look at it!

They lived then very happily in Hevingham ever since, getting fully involved in the community, enjoying their retirement with many of the local clubs in the village and surrounding area. She also volunteered with British Red Cross. Ivy's faith is also very important to her and got involved with the 2 churches in the village. Even in her nineties, she would visit some of the elderly villagers every week until they passed away. A member of the Parochial Church Council for some years, she still continues to support Hevingham St Botolphs Church today. She is blessed to be looked after by her family still and is currently living with her youngest daughter and family in Scotland. We will be gathering as a family to be with her in Scotland for her 100th birthday even though she has said she doesn't want a fuss!

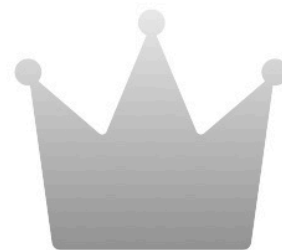

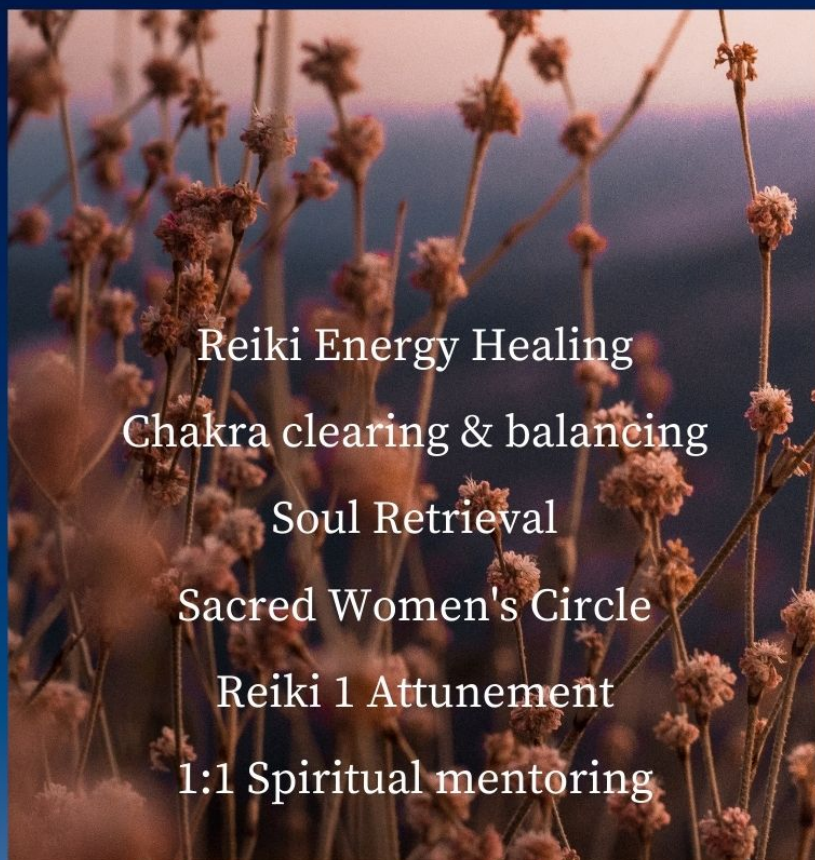
