So you want to be a Parish Councillor?

Four years ago (2019) I became a candidate to join Hevingham Parish Council, along with quite a few 'new faces'. At the same time there were a number of the incumbent councillors who decided not to stand. There are 11 Councillor positions in Hevingham and by coincidence there were 11 candidates. All were therefore elected unopposed; an outcome that seemed to have happened a lot. I can only speculate that most people either were not aware that an election was taking place or that no one else was particularly interested.

Back to 2019 and during my campaign I received comments from people around the village that ranged from 'I didn't know you even could stand as a Councillor' to 'It's just a boys club with people trying to line their own pockets'. One of the reasons I wanted to become a councillor was to change that perception. This was the village I chose to live in and I wanted the actions of the Parish Council to be transparent and above board. Trust in politicians and councils have never been high but this was a Parish Council, which concerned itself exclusively with matters pertaining to Hevingham. It was mundane, everyday mechanisms that should not include hifalutin idealisms or underlying self interest. The Nolan Principles still apply to Parish Councillors as much as Westminster Politicians <https://www.gov.uk/government/publications/the-7-principles-of-public-life> but national politics does not cut the grass or maintain the playground apparatus.

Before I put my candidacy forward in 2019, I attended the council meetings as a member of the public; there were 9 meetings throughout the year. Only one meeting was attended by lots of Parishioners because of a Norfolk house building consultation where some local people had put forward proposals and there were objections enough to motivate people to attend a council meeting (not that it was a Parish Council matter and as it turns out, all the proposals were rejected).

Usually there are less than 5 members of the public attending. And if no one reads the Parish Council minutes, the chances of understanding what the Parish Council actually does is remote. For those who are unsure where to find information, the Hevingham Parish Council Web Site has the monthly minutes published as they are agreed <https://hevinghampc.wixsite.com/hevinghampc> and then repeated in the Hevingham Village News Magazine (on line only, as of Summer 2022 and ending March 2023 if no editor volunteers).

The Parish Council is responsible to keep Hevingham looking maintained and to make improvements for community benefit. It also needs to be a safe place to live in, so there are various maintenance functions to attend to. These include things like grass cutting, hedge trimming, street lighting, play equipment and providing allotments. The Parish Council also puts forward points for consideration to housing applications before District Council decides. Where costs and expenses of these activities are involved, the Parish Council decides where your money, known as a precept, is spent.

There appears quite often to be confusion as to who is responsible for what function. Pot holes is a common example, which is the responsibility of Highways at County Council but it is the responsibility of any individual to report it. It is not the responsibility of the Parish Council; but will do so if spotted.

I think it is fair to say that people often express themselves more when faced with a situation they object to rather than when everything is ticking along nicely or their lives are unaffected. Social media appears to be a common platform for these complaints and occasionally you

will see someone say. 'Someone ought to do something about it', or 'why isn't the Council doing something about it?' So what if that 'someone' is you?

What if you have to become the change you want to see to make a difference? What if the best way to make things happen is to become a Parish Councillor? You can stand from the age of 18 and as young people live in the village as well, we could do with all perspectives. We do have women on the council but to become more representative of the Parish demographic I would encourage more women to stand (currently out numbered by 8 - 3).

The first reason for me writing this article is to ensure that everyone knows how becoming a Councillor works. The second reason is to ensure everyone is aware that the next election for Parish Councillor is May 2023. And yes, if there are more than 11 candidates standing for election, there has to be a public vote.

1. Around mid March 2023 there will be publication of a notice that an election will be organised.
2. To become a candidate you must be living or working in Hevingham (there are other conditions but these would be the most common).
3. You will need two nominations from the Parish electorate to stand.
4. You can stand as an independent person (most of the current Parish Council is made of people independent of political parties).
5. Nominations for candidates have to be received, hand delivered, to Broadland District Council. The deadline for this to be published but is likely to be around the beginning of April.
6. You can campaign to drum up support.
7. Polling Day, if there are sufficient candidates to force a vote, is usually the first Thursday in May. We should know before this date if there will be a vote if more than 11 candidates have fulfilled point 5 above. If elected you become a councillor for 4 years.

If, at any point in the process, you are not sure if you have done something the right way, you can email the Parish clerk for guidance.

Campaigning gives you the chance to say to the electorate why they should vote for you. Is there a particular change you want to make happen? Is there a particular issue that you feel could be tackled at Parish level? Do you want to campaign for better facilities, more of this or less of that? In short, what are you prepared to do that will make a difference to enhance the community or the wellbeing of the electorate? Councillors can do more than agree who cuts the grass. The cheapest way to campaign is with a special edition newsletter, which I will be happy to coordinate if more than 11 people stand. This does not stop you from using Hevingham People or employing any other form of campaigning. Bear in mind that the role of a Parish Councillor is unpaid, so free campaigns only costs your time and effort.

The publication of this article is December 2022, so you have time to decide if you want to grumble and do nothing or actively do something about it. The minimum amount of time being a Parish Councillor is to attend 9 council meetings, which probably amounts to 20 hours a year! So when people say 'I don't have time' you may want to reconsider. If you are elected by the people you have been given a privilege to serve. How much additional time you spend in service to your local community is up to you.

1. APOLOGIES

Apologies were noted from County Cllr D Roper. No contact was received from Cllr A Ramsbottom.

2. DECLARATIONS OF INTEREST AND DISPENSATION REQUESTS

There were no declarations of interest or dispensation requests.

3. MINUTES OF THE LAST MEETING

Minutes of the meeting held on the 7th June 2022 were agreed by all.

4. MATTERS ARISING

- The Chairman has still not been able to speak to PC Lucas Ward but will be asking Councillors to consider some permanent speed activated signs at the September meeting.
- The Chairman advised the shed on plots 1 and 2 of the farmers allotments has now been removed.
- The Clerk reported that she is still awaiting a response from NCC Highways concerning the requested SAM position and the signage near Low Lane despite contacting the Hevingham representative directly. It was suggested that Jerome Mayhew MP should be asked to get involved as this lack of response is unacceptable. All agreed, so the Clerk will action.
- Following the Parish Council's question to BDC's consultation concerning dog fouling, the following was confirmed by BDC: *This PSPO will be policed as it has been for the past 3 years, both by our Officers and the Police. Response will be made when breaches are reported to the Council. Stray and or loose dogs are dealt with separately - the PSPO relates to dogs who are under the control of a person.*

5. PUBLIC PARTICIPATION

- A resident from the Holt Road asked if the Parish Council were aware of a proposed private traveller's site for 4 pitches in Eastgate under the GNLP. The Council were not aware but will look into as there is already a site in Stratton Strawless which doesn't appear to be fully used.
- A resident has asked if anything can be done concerning the current parking situation around the Village Green as it causes issues getting in and out of her drive. Following discussions, it was agreed this will be monitored but it wasn't felt necessary to take any action at this time.
- The Chairman advised he reported the water leak on Halls Corner and it was looked at today - the valve is faulty and will be replaced. The reduction in pressure in the village is not as a result of this however but a faulty booster which will also be attended to.
- Comments have been made on social media regarding the chipping of Low Lane, which it seems was not Scrapped or had the potholes filled before completion of the works. All agreed the Clerk should complain to Highways.
- The Farmers Fete / Auction is taking place on the 6th August and most things are now in place. A Fire Engine will be visiting and a professional auctioneer will be overseeing the 38 lots. The Starting Handle Club will also be participating and there will be stalls to visit with the emphasis on farming and homemade crafts.
- It was reported that whilst the verges in the village have been cut recently, Highways have missed the verge on the left as you pull out of New Road towards The Heath. This is causing visibility issues and is dangerous. All agreed the Clerk should raise with Highways.
- A resident asked if anything could be done about the bends on Brick Kiln Road as they are dangerous. Following discussions it was agreed there was not an issue if people drove to the road condition and speed limit and without any evidence to prove otherwise, there was little point in referring to Highways.
- It was noted that the main village postman is retiring on the 22nd July after 27 years of service. Richard has been a fantastic postman and all will be sad to see him go. Residents are encouraged to thank him in their own ways.

6. MATTERS TO REPORT

7. MATTERS TO REPORT

a. Correspondence

The Clerk had previously circulated a note from BDC regarding a request for an alcohol license for the shop at Cobbleacre Lakes. Although some residents have raised concerns, generally there did not seem to be real opposition to the granting of this.

b. Clerks Report

- The SAM sign will be going up tonight on Brick Kiln Road.

- Most of the Covid signs have now been removed from the play area at the Village Hall but it was agreed that one

will be left for now in light of the current rise in infections. It was noted that safety caps have been installed to cover any bolts.

- The play area has had its annual inspection and there are no major issues to address. The Clerk will ask the village hall handyman to cover the small things that have been highlighted but would like to clarify two points: a) one of the gates has always been left locked for the toddler group to be secured safely in their grassed area but this has been highlighted as a potential bullying risk – all agreed it should remain locked for the toddlers safety.

b) There was a damaged plank on the swing bridge which has been removed and the item is still useable safely. It was agreed this will not be replaced for now as the age of the item means it is likely to need replacing fully in the not-too-distant future.

c. Village Hall Report

- The next meeting is in two weeks. The booking clerk is resigning. The roof is being dealt with in August and some further re-decorating will be completed which means the Hall will be closed for a week.

- The Community Project will be carried forward by the Village Hall Committee, with the help of sub-committees, as

the Parish Council are not able to do this as Custodian Trustees, which means more funding will need to be obtained to cover any VAT but this is not seen as a problem. All agreed that was the correct way to proceed. Although the Community Garden is now open to all, the official opening is now likely to take place in September.

d. Police Report

There have been no further updates since the April figures were released.

e. County Councillor Report (Read by the Chairman)

- I am aware that there are various highways issues still outstanding that I am chasing. Re one of these I did remind Richard Pearson that the timeframe for the white lining is up at the end of July and requested a clear indication of when this will be completed.

County Councillor Report continued/-

- As has been shared elsewhere the roadworks on Cromer Road have been extended for a further month. In discussions with highways they have indicated a hope that there will be completion a little bit sooner than expected.
- Main issue at NCC since the last meeting has been the rising cost of the Norwich Western Link. The total cost has increased from £198m to £251m – however it remains the hope that government will fund 85% of the project. If this is the case the additional cost to Norfolk will be just under an additional £8m. What would be a potential game changer is if government funds less than 85% of the new project cost. There are still many stages to go through but the Council remains committed to completion of the road.
- The other issue is preparations for next year's budget. This will involve a consultation over the summer on a review of the mobile library service. From October onwards there will be the usual main budget consultation but ideas already put forward include more on street parking charges in tourist areas and potential changes to opening times at recycling centres.

8. MATTERS FOR FUTURE DISCUSSION AND DATE OF NEXT MEETING

Parish Partnership Scheme (SAM sign) and Report from Cllr D Holmes on the Vattenfall meeting he will attend on the 21st July.

Next meeting is on the 6th September 2022.

1. APOLOGIES

Apologies were noted from Councillors I Nickalls, S Howes and A Long.

2. DECLARATIONS OF INTEREST AND DISPENSATION REQUESTS

There were no dispensation requests however Cllrs M Williamson, T Palmer and D Holmes declared interests in item 6dii.

3. MINUTES OF THE LAST MEETING

Minutes of the meeting held on the 5th July 2022 were agreed by all.

4. MATTERS ARISING

- The Clerk reported it appears the GNLP is currently being re-considered and so the consultation on this has been delayed.
- The Clerk reported Highways do not consider the grass growing in the new chippings as meeting Highways criteria for intervention and therefore no action is being taken. Tarmac who did the chippings have referred the potholes back to NCC Highways as they do not get involved in repairing potholes.
- The un-cut verge at the junction with New Road and Church Lane should have been cut by now but it was confirmed it hasn't been so the Clerk will chase.

5. PUBLIC PARTICIPATION

- The Farmers Fete / Auction went very well and raised £4066.03 for the proposed bike track at the Village Hall. Thanks to all who helped with that.
- The Hevingivers teamed up with the Tots for the recent garage sale and raised a total of £467.00 which will be shared equally.
- A quiz night is planned for the 30th September 2022 and tickets will be £6.00.
- A ploughing match is also being planned – further details to follow.
- To help raise further funds for the proposed bike track, 2 buckets are going to be superglued together and residents can purchase raffle tickets (£1.00 each) by putting money in the buckets. The buckets will be opened after the Parish Council meeting on the 6th December and filmed live. The winner will be given half the funds with the remaining half going to the proposed bike track.
- Cllr S Benton reported she was given £20.00 by BDC following a Litter Pick she arranged and received a further £200.00 as she was then entered into a draw. These funds are intended to be used in the community and so will be given to the Hevingivers.
- Cllr M Williamson asked if the Parish Council could have an update on the fence which remains on the beck bridge, as the owners were present but they declined to comment. The Chairman stated as this is a Highways issue, the Parish Council cannot get involved further.

The Clerk proposed transferring £5000.00 from the Cambridge B/S account to the current account as the next Precept payment is not due until mid October and this was agreed.

The Clerk also proposed that the handyman is asked to stop all further work until the budget is reviewed in October as his costs have now exceeded the budget figure set and this was agreed.

- ii) The External Auditors report has been received and all is in order with no concerns raised. The appropriate conclusion of audit notice is on the Parish Councils website with all other necessary documentation.
- iii) The five year auditor appointment has now expired and the Parish Council need to agree whether to continue as part of the SAAA sector led auditor appointment regime or opt-out. All agreed to continue in the SAAA regime.

b. Village Magazine

The Chairman advised following discussions in between meetings, it was agreed on a majority, that the magazine will be published online only beginning with the latest Autumn 2022 edition. It was not a decision that the Council wanted to make but printing costs were simply making it un-economical to continue.

There is still a vacancy for the editor's position and unless anyone comes forward, the magazine will cease completely as the Chairman is only continuing as editor until March 2023.

c. Parish Partnership Scheme / Road Safety Community Fund

The Clerk had previously circulated some figures to purchase 2 permanent SAM signs but following discussions, it was agreed the Council would not pursue this at this time.

d. Allotments

i) Updates

The hedge alongside the allotments has now been trimmed and thanks are passed on to the Parish Council by the adjoining property owner.

Cllrs T Palmer, M Williamson and D Holmes then left the meeting

ii) Rents

Following discussions, it was agreed to maintain all rents as they are for now and review again next year.

Cllrs T Palmer, M Williamson and D Holmes then returned to the meeting

iii) Review of Policies

the Clerk had previously circulated minor amendments to the Allotment Rules, Policy and Risk Assessment documents and these were agreed by all.

iv) Future hedge cutting

The Clerk has asked Zak Branch if he would be interested in cutting the hedge on an annual basis and he has provided an estimate of £350.00, depending on growth. No further quotes are required under Financial Regulations as this is under £500.00, unless Councillors would like further estimates obtained. All agreed to appoint Zak.

f. Village Hall handyman

The current handyman feels he is no longer capable of keeping up with the maintenance etc but is prepared to continue until someone else can be found. It was agreed the Clerk will send a list of the duties performed to the Chairman, who will speak to the handyman to see how best to move forward.

g. Anglian Water

The Chairman proposed a complaint letter be sent to Anglian Water with regard to the many leaks that keep occurring in the village and ask why these keep happening and what they propose to do to prevent these continuing. All agreed.

h. Fire Safety Officer

As a result of the risk assessment for the Village Hall being reviewed, it has come to light that the Council should have a Fire Safety Officer as a regular user of the Hall. Cllr D Holmes agreed to take on the role and will arrange a fire drill at an appropriate time.

i. BDC Consultation on table of fares for licensed hackney carriages

All agreed no comments needed to be submitted.

j. Norwich Western Link Pre-planning Consultation

Following discussions around the suggested proposal to stop vehicles turning right out of Shortthorn Road onto the Holt Road, it was agreed the Chairman will attend an event on the 22nd September at Felthorpe Village Hall to see exactly what is proposed, before agreeing any response at the October meeting.

7. MATTERS TO REPORT**a. Correspondence**

b. Report from Cllr D Holmes on Vattenfall meeting 21st July

The meeting was to highlight funding of £100 million which will be coming available next year to local community groups to bid for, specifically with regards to green energy. Cllr Holmes will keep a watch on this as it seems it may be of benefit to the village generally but especially the Hall.

c. Clerks Report

- The clerk reported the latest SAM results which will be printed in the next magazine.
- The £100.00 grant advertised on the village Facebook pages was unfortunately all taken before the Clerk could submit a claim for the residents who came forward – those residents have been informed. Should a further fund be announced, the Clerk will advertise it again.
- The village hall handyman has now dealt with all items requiring attention on the play inspection report except the Daisy Rocker and Baby Swings as he is unable to deal with those. The Chairman will look at them and discuss with the handyman next week.

d. Village Hall Report

- The new bookings clerk is Tanya Wiseman.
- The AGM took place recently and there are a few new committee members.
- The roof has been repaired and the main hall redecorated.
- Bookings are still good despite having to raise prices slightly to cover some of the increased electricity costs. There is no cap for businesses so prices have gone up significantly but they are trying not to pass all of these onto hirers. The Hall still has some of the Covid grant available but they may run at a small loss temporarily.
- The committee have agreed to be the 'funding vehicle' for the Community Project so they can now apply for grants. As all items will be outside, it will fall to the Parish Council, once in place, to insure and maintain the items.

e. Police Report

The Clerk advised there were 3 crimes in the village during May: 1 x Violent and Sexual Offence (on or near Westgate), 1 x Criminal Damage and Arson (on or near Open Space) and 1 x Public Order (on or near The Turn) and there were 3 crimes in June: 3 x Violent and Sexual Offences (1 on or near The Turn and 2 on or near Pound Road). Further information can be accessed via www.police.uk.

f.**i) District Councillors Report**

The third peer review took place in July but the report is still being awaited.

The building move is planned for January 2023.

Everyone should now have received a leaflet about the food waste collections which are due to start in October. If you run out of bags, you should be able to leave a note and more will be left for you.

ii) County Councillor Report

A meeting has been arranged with the local Highways man for next week and Cllr Roper will be visiting the village with him. If you wish to add anything for discussion, please send to Cllr Roper. Cllr Roper is aware the white lines are still outstanding so that will be one of the things discussed.

Cllr Roper still has a small sum available should we have any small projects he can cover. The sign on the Holt Road will be covered by that.

The County Council have submitted a new bid to the Government for devolved powers but the outcome of that may depend on the new PM.

During the recent hot spells, the fire brigade took 800 calls a day in July and 1600 calls a day in August. Usually, they take 80-100 a day. A review is now underway for the future on how to manage hot seasons and it is hoped the fire brigade can work with farmers on that.

Cllr D Holmes asked if planning would be needed for the bike track at the hall – Cllr Roper will look into that.

Cllr J Norton asked if more deer signs were going up as there didn't seem to be very many – Cllr Roper will find out.

8. MATTERS FOR FUTURE DISCUSSION AND DATE OF NEXT MEETING

Village Hall Handyman, Norwich Western Link Consultation, Grass Cutting at the Church, Street Lighting Contract and Budget Review.




